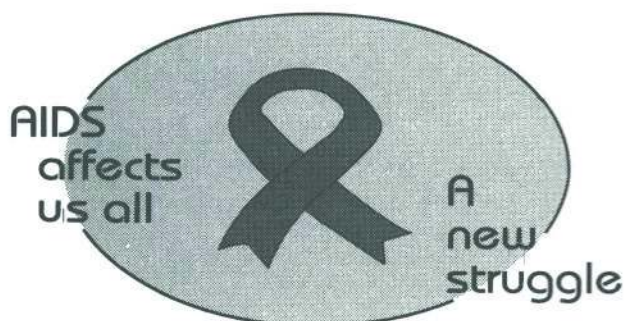

FILMS AND PUBLICATIONS ACT, 1996 (ACT No. 65 OF 1996)

FILMS AND PUBLICATIONS REGULATIONS

The Films and Publication Board has, in terms of section 31(2) of the Films and Publications Act, 1996 (Act No. 65 of 1996), made the regulations in the Schedule.

SCHEDULE

Amendment of Regulation 1 of the Second Amendment to the Films and Publications Regulations, 1998 (No. R. 1374 of 23 October 1998) and Regulation 2 of the Films and Publications Regulations (Games), 1999 (No. R. 348 of 15 March 1999)

1. Regulation 1 of the Second Amendment to the Films and Publications Regulations, 1998, and Regulation 2 of the Films and Publications Regulations (Games), 1999, are hereby amended by the substitution for paragraphs (a) of Regulation 1 of the Second Amendment to the Films and Publications Regulations, 1998 and (a) of Regulation 2 of the Films and Publications Regulations (Games), 1999, of the following paragraph:

- “(a) A submission of a film or game, including a trailer of a film or game, for classification in terms of section 18 of the Act, shall be made to the Board on the prescribed forms, together with the applicable fee. Where the applicant has been exempted, in writing upon application, from the cash-on-submission system, the classification fee shall be paid immediately upon receipt of an invoiced statement of account from the board, failing which the Board may revoke any exemption granted from the cash-on-submission system and take such steps as may be necessary for the recovery of such fee.”

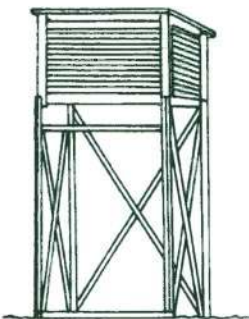
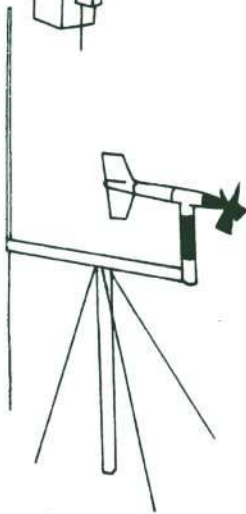
