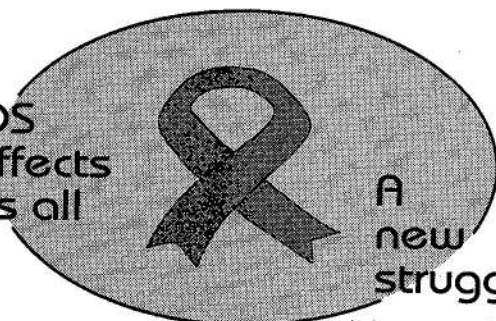

PRESENT STATUS OF THE ABOVE PROPERTIES



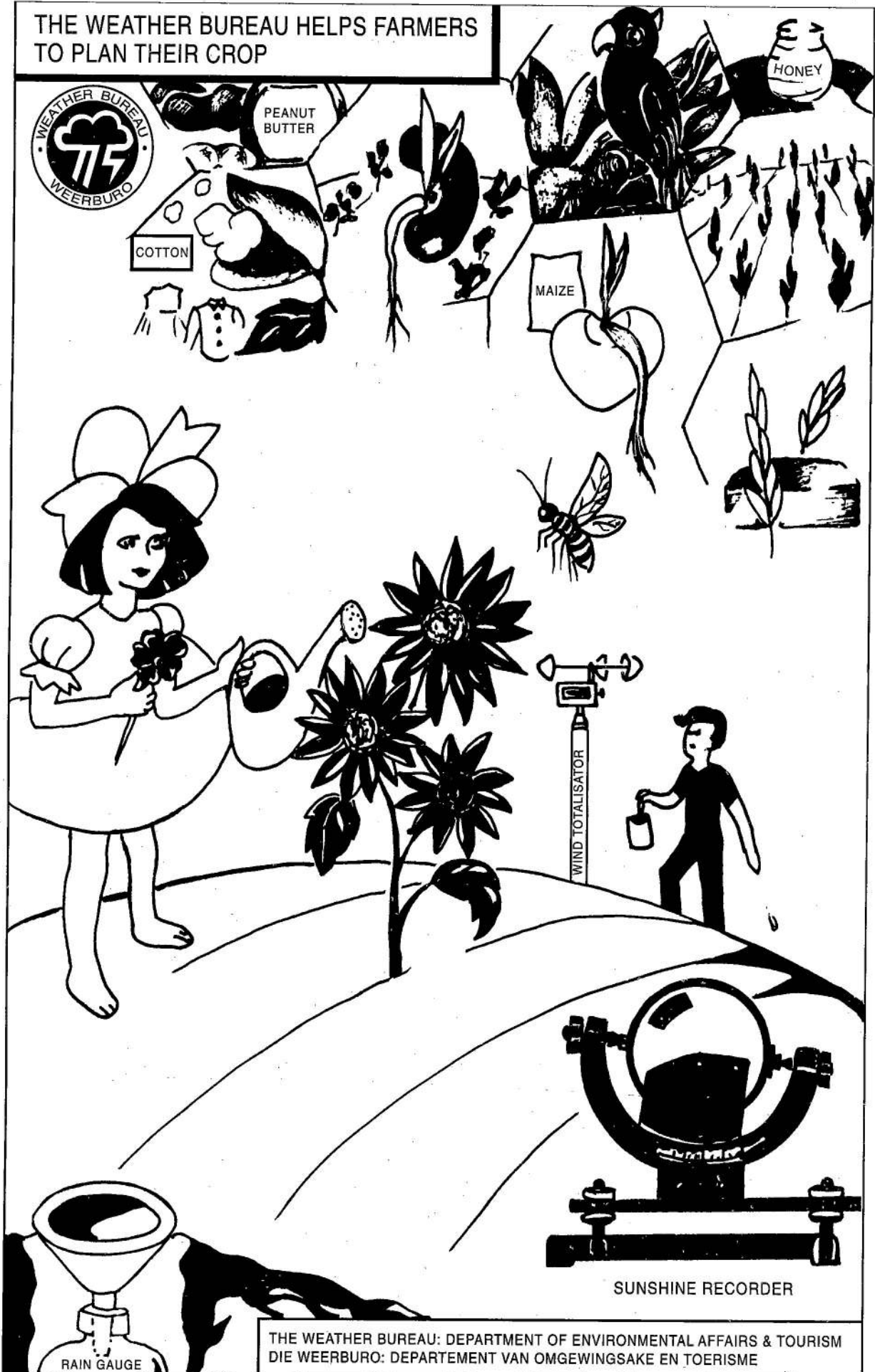
