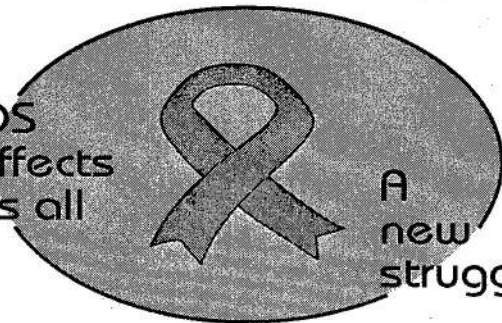

INDEPENDENT BROADCASTING AUTHORITY

APPLICATION TO AMEND BROADCASTING LICENCE: SOWETO MEDIA RESOURCE CENTRE

The Independent Broadcasting Authority hereby gives notice in accordance with section 52 (2)(a) of the Independent Broadcasting Authority Act No. 153 of 1993 as amended, that an application has been received from Soweto Media Resource Centre (SRCM) broadcasting as Soweto Community Radio, in terms of section 52(1)(c) for an amendment of its Licence Conditions. Soweto Community Radio was sharing frequency 105.8 Fm with Buwa Community Radio. The licence of Buwa Community Radio has expired and it no longer wishes to apply for a new licence. By agreement with Buwa Community Radio SRCM is applying to increase its broadcasting hours from 12hours to 24hours per day, to change its programming schedule, to absorb the assets and liabilities of Buwa Community Radio and to change its broadcasting name from Soweto Community Radio to Jozi FM.

The application, the relevant Schedules and any written representations received pursuant thereto are available for inspection by any interested parties during office hours of the Authority.

The effective date of the proposed amendment, if granted, would be the date on which the Authority's decision on the application would be published.
