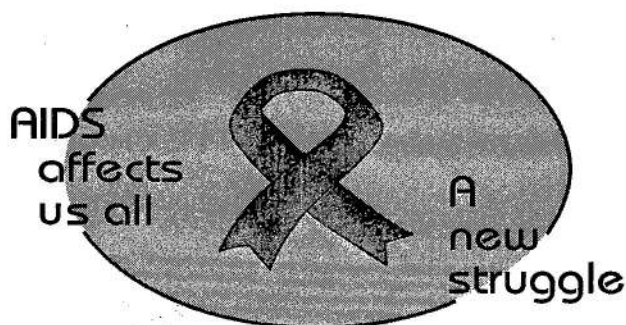

In terms of the share purchase agreement Ford would acquire the shares held by Anglo South Africa (Proprietary) Limited in SAMCOR, constituting 45 per cent of the issued shares in SAMCOR.
