

COMPETITION COMMISSION

NOTICE OF A COMPLAINT LODGED WITH THE COMMISSION IN RESPECT OF A CONTRAVENTION OF A PROHIBITED PRACTICE CONTAINED IN THE COMPETITION ACT, 1998.

Notice is hereby given to the effect that a complaint has been lodged with, and accepted by, the Competition Commission, by Anti-waste Drum Reconditioners in terms of section 44 of the Competition Act 1998 ("the Act"). On the main, without limiting the scope of this investigation, the allegation appears to relate to a transgression of sections 4, 5 and 8 of the Act. The allegations are that:

- Enviro-Drum and its associates established the South African Drum Reconditioners Association (SADRA) as a vehicle for collusive practices;
- Enviro-Drum is using its position of power in SADRA to decide where, when and who does reconditioning of drums in the relevant market.

This notice is issued in terms of Rule 18(1)(b) of the "RULES FOR THE CONDUCT OF PROCEEDINGS IN THE COMPETITION COMMISSION" published in Notice No. 1938 of Government Gazette No. 20384 of 20 August 1999, and is intended to invite parties who believe that they have a material interest in this matter to submit Form CC 2 to the Competition Commission. This form was published in Notice No. 1939 in Government Gazette No. 20385 of 20 August 1999.
