### **INDEPENDENT BROADCASTING AUTHORITY**

#### **APPLICATION TO AMEND BROADCASTING LICENCE: SOUTH AFRICAN BROADCASTING CORPORATION (SABC)**

The Independent Broadcasting Authority gives notice, in accordance with Section 52 of the Independent Broadcasting Authority Act, No. 153 of 1993, (the Act) that an application has been received for amendments to the South African Broadcasting Corporation's (SABC) licence. The amendment if granted, would result in the expansion of the SABC's television services by way of self-help relay stations as set out in the attached Schedule. Radio 2000 would also be expanded through a self-help station.

The SABC has also applied to reduce the transmission power of SABC2 TV Channel in the following three areas, to 'afford efficient utilisation of the available spectrum':

- 1. Outdtshoorn from 80kW ERP TO 16kW ERP**
- 2. Riversdale from 80 kW TO 20kW ERP**
- 3. Piketberg from 100 kW TO 10kW ERP**

This reduction in power brings the services of SABC2 to the same level as all the PBS services at the same sites.

The self-help stations would provide a service to remote areas that are not covered by the national public service broadcasting network. In most cases, the self-help stations proposed are additions to existing sites, in order to expand the number of services available in that area.

The application, relevant Schedules and any written representations received pursuant thereto are available for inspection by any interested parties during office hours of the Authority.

The effective date of the amendment would be the date on which the Authority's decision on the application would be published.
