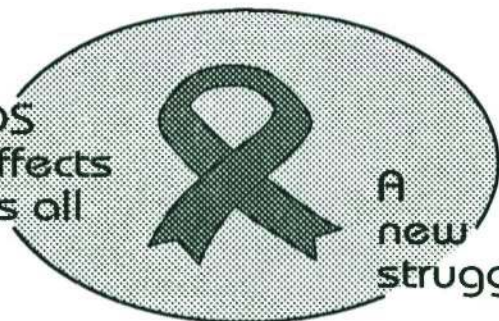

PUBLIC FINANCE MANAGEMENT ACT, 1999
EXEMPTIONS

I, TREVOR ANDREW MANUEL, MINISTER OF FINANCE, acting in terms of section 92 of the Public Finance Management Act, 1999 (Act 1 of 1999), hereby exempt the institutions specified in the first column from the provisions of that Act specified in the second column to the extent specified in the third column of the Schedule.

INSTITUTION EXEMPTED	SECTION OF ACT	EXTENT OF EXEMPTION
Public entities listed in Schedule 3 of the Act	7(1)	Exemption from the whole of the section until 1 January 2001
Provincial education departments	38(1)(j)	Exemption to the extent that the provision does not apply to transfer payments to schools until 31 January 2001
Provincial health departments	38(1)(j)	Exemption to the extent that the provision does not apply to transfer payments to hospitals and clinics until 31 January 2001
All departments, trading entities and constitutional institutions	40(3)(a)	Exemption to the extent that the section requires the annual report and financial statements of the institution to fairly present the institution's performance against predetermined objectives, until 1 April 2002
Public entities listed in Schedules 2 and 3 of the Act	66(1)	Exemption from the whole of the section until 1 April 2001
