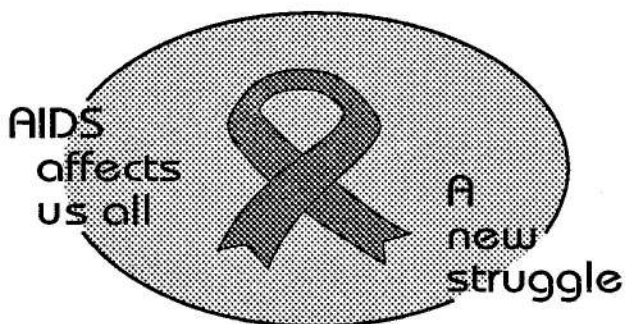

#### COMPETITION COMMISSION

#### **NOTIFICATION OF PROPOSED TRANSACTION BETWEEN AUTO INDUSTRIAL BRAKE AND CHASSIS INVESTMENT HOLDINGS (PTY) LTD AND LEMFORDER SA (PTY) LTD AND BREMBO PARTICIPATIONS B.V.**

The Competition Commission hereby gives notice in terms of rule 26 (8) (a) (iii) that Auto Industrial Brake and Chassis Investment Holdings (Pty) Ltd ("AIBC") has filed a notification with the Competition Commission on 15 February 2000, in terms of section 13 of the Competition Act, No. 89 of 1998. The aforesaid notice is in respect of the proposed sale of two thirds of its issued share capital to Lemforder SA (Pty) Ltd and Brembo Participants B.V., with the two companies getting an equal number of shares of the aforesaid capital.

The four existing subsidiaries in Auto Industrial Group Holdings Ltd such as Auto Industrial Spartan (Pty) Ltd, Hubco Forgings SA (Pty) Ltd, Auto Industrial Foundry SA (Pty) Ltd and Martemp Heat Treatment (1992) (Pty) Ltd will be incorporated into AIBC as part of the transaction. The aforesaid subsidiaries are currently involved in the manufacturing of automotive components such as wheel-end corner modules, brake discs, brake drums and chassis technology parts.

The Competition Commission is evaluating and assessing the proposed transaction.
