

## NOTIFICATION OF PROPOSED TRANSACTION BETWEEN NASPERS LTD ("NASPERS") AND THE EDUCATION INVESTMENT CORPORATION LTD ("EDUCOR")

The Competition Commission hereby gives notice in terms of rule 26 (8) (a) (iii) that Naspers Ltd ("Naspers") has filed a notification with the Competition Commission on 17 February 2000, in terms of section 13 of the Competition Act, No. 89 of 1998. The aforesaid notification is in respect of the proposed acquisition of 40% of the issued share capital of a new company, NewEd by Naspers.

However, NewEd is a wholly owned subsidiary of Educor. The acquisition of the aforesaid capital by Naspers depends upon the consolidation by Educor of its education business in NewEd and the transfer by Naspers of its National Colleges business to NewEd.

The Competition Commission is evaluating and assessing the proposed transaction.
