

**BOARD NOTICE 36 OF 2000****SECURITY OFFICERS'S INTERIM BOARD****NOTICE TO ALL BOARD ACCREDITED TRAINING ESTABLISHMENTS AND PERSONS  
WITH AN INTEREST IN THE TRAINING OF SECURITY OFFICERS**

It is a matter of public record that a new framework in respect of the training of security officers is being developed as envisaged by *inter alia* the South African Qualifications Authority Act, No. 58 of 1995, and the Skills Development Act, No. 97 of 1998. Furthermore, the Board is in the process of advising the Minister for Safety and Security on changes regarding the regulatory framework of the security officer industry in general. There will in the foreseeable future also be legislative changes in this regard.

In view of the legislative and related changes referred to above, as well as other relevant considerations, the Board wishes to draw the attention of all interested parties to the immediate implementation of the following measures adopted by it in terms of *inter alia* section 3 (a) and section 3 (b) of the Security Officers Act, No. 92 of 1987:

1. Until such time as a new regulatory dispensation in respect of the security industry, and in particular the training of security officers, is implemented, the Board will not consider any further applications for accreditation as training establishments.
2. No application for any form of accreditation (whether it be in respect of a training establishment or as an instructor) by an owner, manager, instructor of any former accredited training establishment which has had his/her or its, according to the case, accreditation certificate withdrawn, will be considered by the Board.
3. The Board will no longer accept any facsimile, e-mail or photocopy of training course reports or training certificates, whether certified or otherwise as proof of successful training undertaken by security officers at accredited training establishments. In addition to an evaluation of original course reports submitted to it, the Board will undertake any other reasonable steps necessary to verify the accuracy of a course report submitted to it. This may include, but is not limited to, an assessment of the outcomes of the training undergone by a security officer.
4. Existing training establishments must take note that any failure by them to strictly abide by any relevant provision of the Security Officers Act, No. 92 of 1987 or the Training of Security Officers Regulations, 1992, as amended (published in, for example, *Government Gazette* No. 14178 of 31 July 1992, and amended in *Government Gazette* No. 14877 of 25 June 1993) will result in proceedings and procedures as set out in regulation 18 of the said regulations being summarily implemented.
