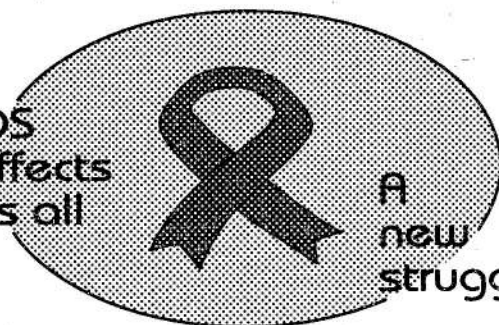

In terms of regulation 3(b) of Regulation 1352 dated 12 November 1999 a person who uses water as contemplated in section 21 of the National Water Act, 1998 (Act No. 36 of 1998) must, when called upon by the responsible authority to do so, register the water use.

- (h) disposing in any manner of water which contains waste from, or which has been heated in, any industrial or power generation process
- (i) altering the bed, banks, course or characteristics of a watercourse
- (j) removing, discharging or disposing of water found underground if it is necessary for the efficient continuation of an activity or for safety of people
- (k) using water for recreational purposes

- e) Stream flow reduction activities (afforestation): - All species of wattle, blue-gum, poplar, pine or any other exotic tree species planted in commercial plantations (including woodlots)

3. EXCLUSIONS

The following water use(s) are excluded from registering in terms of this Notice-

- (a) Schedule 1 uses in terms of the National Water Act
- (b) Scheduled water use by members of an Irrigation Board or Water User Association in a distribution system where they are supplied by the Board or Association. (The Board or Association will be registered as a bulk supplier. Other water uses must be registered separately)
- (c) The taking of water from a bulk supplier or a communal domestic water supply scheme, where the bulk use will be registered as a whole.

PROMULGATION OF STRUCTURAL TARIFF
ADJUSTMENTS FOR LARGE AND SMALL POWER USERS****1. BACKGROUND**

- 1.1 Eskom has developed a long-term tariff plan aimed at giving customers and the National Electricity Regulator (NER) as much advance notification of future tariff developments as possible.
- 1.2 The NER supports the principle of cost-reflective tariffs. However, due to major uncertainties in the Electricity Supply Industry as well as the lack of clear definitions and objectives for cost reflectiveness, all pricing restructuring, driven by the cost reflectiveness objective, are put on hold, pending further direction from the NER. Pricing developments aimed at aligning existing tariffs or the introduction of new tariffs where there is a proven need, will be continued.
- 1.3 All prices quoted in this notice are in 2000 Rand value and therefore subject to Eskom's annual price increase. **Tariffs and / or tariff components not mentioned in this notice will not be subject to structural change, only to the general price increase.** Tariffs quoted for 2002 onwards are subject to review and promulgation in 2001, but are given here as advance notice of probable future changes.

2. LARGE POWER USERS

The following structural changes will be introduced with effect from 1 January 2001.

2.1 ALIGNMENT OF THE kW AND kVA TARIFF OPTIONS

The kW demand charges of Nightsave will be increased by 1,21%, above Eskom's annual price increase, in order to improve alignment of the kW and kVA tariffs at a 0,85 power factor. From 2001 the tariffs will align at a power factor of 0,87. A further two years will be required to fully phase in the stated objective.

Customers on the kW tariff option receive two main benefits. Firstly the metering integration period is sixty minutes, as opposed to the thirty-minute period applied to all other tariffs. Secondly customers on the kW option do not pay for reactive energy consumption. With the kW and kVA tariffs currently breaking even at a power factor of 0,89, customers with a lower power factor are being undercharged.

The proposed rates (in 2000 Rand value) are shown in table 1 below.

2.2 TIME-OF-USE SEASONS

The Time-of-Use seasons will be changed to 9 months of low demand and 3 months of high demand. The latter will be the months of June, July and August.

3. SMALL POWER USERS

The following structural changes will be introduced with effect from 1 January 2001.

3.1 LANDRATE 1, 2 AND 3

Eskom will continue the process, started on 1 January 1997, of phasing out the declining block rate structure of the Landrate range of tariffs. The structural changes in 2001 involve reducing the high-energy block from 600 kWh per month to 500 kWh per month and increasing the basic charge by a commensurate amount. This adjustment is required to reduce the cross-subsidy to low and irregular usage customers.

The following tariffs, as shown in Table 3, will be applicable:
