GOVERNMENT NOTICE GOEWERMENTSKENNISGEWING

DEPARTMENT OF WATER AFFAIRS AND FORESTRY DEPARTEMENT VAN WATERWESE EN BOSBOU

REQUEST TO REGISTER A WATER USE

In terms of regulation 3(b) of Regulation 1352 dated 12 November 1999 a person who uses water as contemplated in section 21 of the National Water Act, 1998 (Act No. 36 of 1998) must, when called upon by the responsible authority to do so, register the water use.

I, Hendrik Bernardus Heymans Rossouw in my capacity as Regional Director: Northern Province duly delegated by the Minister of Water Affairs and Forestry hereby request that all persons who use water as set out below must register their water use.

1. WATER USE

The following water uses in terms of section 21 of the National Water Act, 1998 must be registered:-

- (a) taking water from a water resource
- (b) storing water
- (c) impeding or diverting the flow of water in a water course
- (d) engaging in a stream flow reduction activity (afforestation only at this stage)
- (e) engaging in a controlled activity: irrigating with waste or water containing waste generated through any industrial activity or by a water works
- (f) discharging waste or water containing waste into a water resource through a pipe, canal, sewer, sea outfall or other conduit
- (g) disposing of waste in a manner which may detrimentally impact on a water resource
- (h) disposing in any manner of water which contains waste from, or which has been heated in, any industrial or power generation process
- (i) altering the bed, banks, course or characteristics of a watercourse
- (j) removing, discharging or disposing of water found underground if it is necessary for the efficient continuation of an activity or for safety of people
- (k) using water for recreational purposes.

2. Exclusions

The following water uses are excluded from registering in terms of this Notice-

- Schedule 1 uses in terms of the National Water Act
- Scheduled water use by members of an Irrigation Board or Water User Association in a distribution system where they are supplied by the Board or Association (**Other water uses not supplied by the Board or Association must be registered by the members**)
- the taking of water from a bulk supplier or a communal scheme where the bulk use will be registered as a whole.

3. Area of applicability

This Notice is applicable to all water uses set out in paragraph one above within the following Water Management Areas:

- Limpopo
- Levuvhu/Letaba
- Olifants, only of properties situated within the Northern Province
- Crocodile West and Marico, only of properties situated within the Northern Province

4. Registration Forms

The Regional office of the Department of Water Affairs and Forestry in Pietersburg is going to co-ordinate the registration of water uses on a drainage region basis. Before registration takes place in a drainage region, the Department will inform water users by means of the media, posters, etc of the date of water use registration for that drainage region and also of the address where officials of the department will assist water users with the registration process. Water users must submit their completed registration forms to the address set out above on or before the 31 day of March 2001.

6. Failure to register

Any person who fails to comply with this Notice is guilty of an offence.

VERSOEK DAT 'N WATERGEBRUIK GEREGISTREER WORD

Kragtens regulasie 3(b) van Regulasie 1352 gedateer 12 November 1999 moet enige persoon wat water gebruik soos bedoel in artikel 21 van die Nasionale Waterwet, 1998 (Wet Nr.36 van 1998) die watergebruik registreer indien daartoe versoek deur die verantwoordelike gesag.

Ek, Hendrik Bernardus Heymans Rossouw in my hoedanigheid van Streekdirekteur: Noordelike Provinsie, behoorlik gedelegeer deur die Minister van Waterwese en Bosbou, versoek hiermee dat alle persone wat water gebruik soos hieronder uiteengesit, hulle watergebruik moet registreer.

1. WATERGEBRUIK

Die volgende watergebruike ingevolge artikel 21 van die Nasionale Waterwet moet geregistreer word:-

- (a) die neem van water vanuit 'n waterhulpbron
- (b) die opgaar van water
- (c) die belemmering of die wegkeer van die vloei van water in 'n waterloop
- (d) die deelname aan 'n stroomvloeiverminderingsbedrywigheid (net bebossing op hierdie stadium)
- (e) die deelname aan 'n beheerde bedrywigheid : besproeiing van enige grond met afval of water wat afval bevat wat deur enige industriële bedrywigheid of deur 'n waterwerk voortgebring is
- (f) die storting van afval of waterbevattende afval in 'n waterhulpbron deur middel van 'n pyp, kanaal, riool se uitloop of ander geleiding
- (g) die beskikking oor afval op 'n wyse wat nadelig op 'n waterhulpbron kan inwerk
- (h) die wegdoening op enige wyse, van water wat afval bevat van, of wat verhit is in, 'n industriële of kragopwekkingsproses
- (i) die verandering van die bedding, walle, loop of kenmerke van 'n waterloop
- (j) die verwydering, storting of wegdoening van water wat ondergronds gevind is, indien dit nodig is vir die doeltreffende voortsetting van 'n bedrywigheid of vir die veiligheid van mense
- (k) die gebruik van water vir ontspanningsdoeies.

2. VRYSTELLINGS

Die volgende watergebruike is vrygestel van registrasie in terme van hierdie kennisgewing-

- Bylae 1 gebruike in terme van die Nasionale Waterwet
- Ingelyste watergebruik deur lede van 'n Besproeiingsraad of Watergebruikersvereniging binne 'n verspreidingsstelsel waar die water voorsien word deur die Raad of Vereniging geregistreer word nie (**Ander watergebruik(e) deur die lede, wat nie deur die Raad of Vereniging beheer word nie, moet wel deur die lede geregistreer word**)
- Die neem van water van 'n grootmaatvoorsiener of 'n gemeenskapskema, in welke geval die grootmaatverbruik as 'n geheel gerigstreer sal word.

3. TOEPASLIKE GEBIED

Hierdie Kennisgewing is van toepassing op alle watergebruike soos uiteengesit in paragraaf een hierbo binne die volgende Waterbestuursgebiede:

- Limpopo
- Levuvhu/Letaba
- Olifants, net van daardie eiendomme wat in die Noordelike Provinsie gelee is.
- Krokodil Wes en Marico, net van daardie eiendomme wat in die Noordelike Provinsie gelee is.

4. REGISTRASIE VORMS.

Die Streekskantoor van die Departement van Waterwese en Bosbou in Pietersburg gaan die registrasie van watergebruik(e) op 'n dreineringsstreekbasis koördineer. Voordat die Departement die registrasie van watergebruik(e) in 'n dreineringsstreek aanpak, sal alle watergebruikers in daardie dreineringsstreek deur middel van die media, plakkaat ens. van die datums wanneer registrasie sal plaasvind, in kennis gestel word en ook van die adresse waar beamptes van die Departement watergebruikers behulpsaam sal wees met die registrasieproses.
