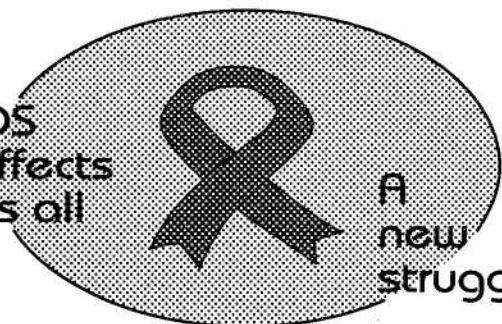

PROHIBITION OF THE MAKING OF FIRES IN THE OPEN AIR, THE DESTRUCTION BY BURNING OF GROUND COVER, INCLUDING SLASH, THE CLEARING OR MAINTENANCE OF A FIRE BELT BY BURNING OR THE EXECUTION OF BLOCKBURNS: KWAZULU-NATAL

I, Douglas Olën, acting in my capacity as Acting Regional Director: Central Region: Forestry: Department of Water Affairs and Forestry, duly authorised thereto by the Director-General of the Department of Water Affairs and Forestry, hereby declare, in terms of section 25 (1), (2) and (3) of the Forest Act, 1994 (Act No. 122 of 1994), that in my opinion State forests or private forests in the areas indicated in the Schedule hereto, are subject to an extraordinary fire hazard. I therefore—

- (1) direct that in the areas and during the said periods indicated in the Schedule no person shall from 12:00 for Zululand Interior Areas and 18:00 for Northern Natal, Natal Midlands and Zululand Coastal Areas on Fridays to 06:00 on Mondays **make a fire in the open air**, or if such a fire has been made allow it to continue to burn or add fuel thereto, otherwise than—
 - (a) fires made within a demarcated picnic or camping area or caravan park or holiday resort, but only at places within such a demarcated area as have been specifically prepared and maintained for that purpose;
 - (b) fires for the preparation of food on residential stands which are adequately protected against fire;
 - (c) fires made on residential and industrial stands in proclaimed townships; and
 - (d) fires to facilitate the harvesting of sugarcane, which is to be allowed from 18:00 on Fridays to Saturdays 07:00 in the Zululand Interior Areas, 08:00 in the Northern Natal and Zululand Coastal Areas and 10:00 in the Natal Midlands Areas, as well as, 17:00 on Sundays to 06:00 on Mondays;
- (2) direct that in the area mentioned and during the period indicated in the Schedule, no person shall **destroy any ground cover**, including any slash or harvest residue by burning other than maize harvest residue, which may be destroyed from 14:00 to 24:00 daily, except from 18:00 on Friday to 14:00 on Mondays subject to regulation 12, promulgated in terms of the Conservation of Agricultural Resources Act, 1993 (Act No. 43 of 1993);
- (3) direct that in the areas mentioned and during the period indicated in the Schedule, the **clearing or maintenance of fire belts** by burning is prohibited;
- (4) direct that in the areas mentioned and during the period indicated in the Schedule, the **execution of block burns** including the burning of veld, may not take place from 12:00 for Zululand Interior Areas and 18:00 for Northern Natal and Natal Midlands on Friday to 06:00 on Mondays subject to regulation 12, promulgated in terms of the Conservation of Agriculture Resources Act, 1993 (Act No. 43 of 1993), and in consultation with local interest parties and the implementation of reasonable precautions to ensure that fires do not spread.

These prohibitions or part thereof as well as the period(s) of validity can be lifted or amended by the Regional Director, where and/or when circumstances permit, subject to review by the local/nearest Fire Protection Association.

- (a) footwear, excluding bespoke made footwear;

- (b) (i) the preparation of cured or uncured hides and/or skins for tanning; for this purpose "preparation of hides and/or skins for tanning" without detracting from its ordinary or technical meaning, includes the following: Washing, soaking, fleshing, deburring, liming, unhairing, dewooling, the removal of scales, deliming, bating and pickling; and
- (ii) the tanning of the cured or uncured hides and/or skins; and or

- (iii) the retanning and/or dyeing and/or drying and/or softening and/or buffing and/or dressing and/or finishing and/or laminating of leather and/or the combing and/or shearing and/or ironing of hides and/or skins with the wool or hair on; and

Pelts with or without the fur attached; sheepskins with or without the wool on; game and goat skins with or without the hair attached; all types of reptile skins, and bird skins with or without the feathers attached: Provided that the activities listed under subparagraph 2 (b) and (c) shall not include —

- (aa) the manufacture of metal components and/or attachments;
- (bb) the manufacture of canvas bank bags, canvas kitbags, canvas rucksacks, canvas haversacks, canvas sampling bags and canvas explosives bags;
- (cc) the manufacture of any article from rubber;
- (dd) the manufacture of any article or the practice of any trade or occupation covered by the "Printing Industry" which, without in any way limiting the generally accepted meaning of the term, means the industry or undertaking in which employers and employees are associated for the production of printed matter of any nature whatsoever;
- (ee) the manufacture of any article from metal or any kind of container (with or without metal parts) from fibre and/or cardboard (corrugated or otherwise) and/or paper or any compound of paper and/or any like material a constituent part of which is fibre and/or cardboard and/or paper and/or any constituent of paper and/or plastic, but excluding the manufacture wholly or mainly from fibre or plastic sheeting material of trunks, attaché cases, bags and all similar containers designed to hold personal effects, musical instruments and sporting kit.

- 3. The industry in which employers and employees are associated for the manufacture, wholly or mainly from leather, of footballs, punchballs, netball balls and boxing gloves, in the Magisterial District of Durban as it was constituted as at 25 November 1974.
- 4. (a) That portion of the Leather Industry in the Magisterial Districts of Bellville, Germiston, Johannesburg, Middelburg (Transvaal), Pretoria, Roodepoort and The Cape, as those areas were constituted as at 21 February 1980, in which employers and their employees are associated in establishment in which leather goods are not manufactured, for the manufacture, from materials other than leather, of—
 - (i) attaché cases, bags and all other containers designed to hold personal effects, sporting kit and documents;
 - (ii) harnesses, bridles, saddlery, leggings, stirrup straps, shopping bags, wallets, purses, watch straps, wrist straps, rug straps, braces and all other like articles irrespective of their description but which are designed as substitutes for any of the aforementioned.
- (b) That portion of the Leather Industry in which employers and their employees are associated for the manufacture of travelling requisites, including trunks, from materials other than leather, fibre wood, cloth, canvas or fabric or any combination thereof:

Provided that paragraphs (a) and (b) above shall not be construed to include:

- (i) the manufacture of metal components and/or attachments;
- (ii) the manufacture of canvas bank bags, canvas kit-bags, canvas rucksacks, canvas haversacks, canvas sampling bags and canvas explosives bags;

- (iii) the manufacture of any article from rubber;
- (iv) the manufacture of any article or the practice of any trade or occupation covered by the "Printing Industry" which, without in any way limiting the generally accepted meaning of the term, means the industry or undertaking in which employers and their employees are associated for the production of printed matter of any nature whatsoever;

 - (a) preparation of cured or uncured hides and/or skins for tanning; for this purpose "preparation of hides and/or skins for tanning", without detracting from its ordinary or technical meaning, includes any of the following: Washing, soaking, fleshing, deburring, liming, unhairing, dewooling, the removing of scales, deliming, bating and pickling; and
 - (b) tanning of the cured or uncured hides and/or skins; and/or
 - (c) retanning and/or dyeing and/or drying and/or softening and/or buffing and/or dressing and/or finishing and/or laminating of leather and/or the combing and/or shearing and/or ironing of hides and/or skins with the wool or hair attached; and
 - (d) cutting of upholstery panels from leather;

Provided that for the purposes of paragraphs (a) to (c) the expression "hides and skins" includes the following:
