

NOTICE OF THE DECISION RE: APPLICATION TO AMEND BROADCASTING LICENCE BY THE SOUTH AFRICAN BROADCASTING CORPORATION (SABC)

The Independent Broadcasting Authority hereby gives notice in accordance with the provisions of section 52(4) of the Independent Broadcasting Authority Act, Act No. 153 of 1993, that the Authority has decided as stated below, in respect of an application by the South African Broadcasting Corporation (SABC) to amend its Public Broadcasting Service (PBS) Licence. The amendment would result in the expansion of the SABC's television services by way of self-help relay stations.

The application was published in the *Government Gazette No 21038* of 29 March 2000.

The Authority decided that:

- 1. There is no need to hold a hearing as the matter could be decided based on the information contained in the documents submitted;
- The SABC's application to reduce the transmission power of SABC2 TV Channel in the areas below, "to afford efficient utilisation of the available spectrum' has been granted. This reduction in power brings the service of SABC2 to the same level as all the PBS services at the same sites.
- 2.1 Outdtshoorn from 80kW to 16kW ERP
- 2.2 Riversdale from 80kW to 20kW ERP
- 2.3 Piketberg from 100kW to 10kW ERP
- 3. The application relating to the Self-Help stations under 3.1 below has been granted.

The Independent Broadcasting Authority hereby gives notice in accordance with the provisions of section 52 (4) of the Independent Broadcasting Authority Act, no 153 of 1993, as amended, that it has decided as stated below, in respect of the application by Midi TV (Pty) Ltd for the amendment of certain of its licence conditions. Midi TV (Pty) Ltd submitted its application on 03 August 1999. It was published in the *Government Gazette* No.20408 of 23 August 1999. A hearing was held on 09 and 10 November 1999.

Midi had applied, amongst other things to have Schedule B2 of its licence conditions amended to include six new transmitters in Amanda Glen, Aurora, Clifton, Linmeyer, Mulbarton and Verulam.

The Authority decided to grant the application in respect of Linmeyer, Mulbarton and Verulam.
