LOCAL GOVERNMENT:
CROSS-BOUNDARY MUNICIPALITIES ACT, 2000

(Assented to 30 June 2000.)*

ACT

To give effect to section 155(6A) of the Constitution by authorising the provincial executives affected to establish cross-boundary municipalities; to provide for the re-determination of the boundaries of such municipalities under certain circumstances; and to provide for matters connected therewith.

PREAMBLE

WHEREAS the Municipal Demarcation Board established by section 2 of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998), has indicated the desirability for certain municipal boundaries to extend across provincial boundaries;

AND WHEREAS national legislation must authorise the respective provincial executives to establish a municipality within a municipal area that extends across a provincial boundary,

BE IT THEREFORE ENACTED by the Parliament of the Republic of South Africa, as follows:—

Establishment of cross-boundary municipality

1. The members of the Executive Councils responsible for local government in the provinces indicated in the first column of the Schedule are hereby authorised to establish a municipality in the municipal area mentioned in the second column of the Schedule opposite such provinces. 5

Re-determination of boundaries

2. The boundaries of a municipality authorised by this Act may only be re-determined under circumstances other than those provided for in section 90(5) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998)— 10

- (a) with the concurrence of the legislatures of the provinces involved; and
- (b) if the re-determination is authorised by national legislation.

Short title

3. This Act is called the Local Government: Cross-boundary Municipalities Act, 2000. 15

Om gevolg te gee aan artikel 156(6A) van die Grondwet deur die provinsiale uitvoerende gesag wat geraak word, te magtig om oorgrensmunisipaliteite in te stel; om voorsiening te maak vir die herbepaling van die grense van sodanige munisipaliteite in sekere omstandighede; en om voorsiening te maak vir aanleenthede wat daarmee in verband staan.

AANHEF

NADEMAAL die Munisipale Afbakeningsraad wat by artikel 2 van die Wet op Plaaslike Regering: Munisipale Afbakening, 1998 (Wet No. 27 van 1998), ingestel is, aangedui het dat dit wenslik is dat sekere munisipale grense oor provinsiale grense heen strek;

EN NADEMAAL nasionale wetgewing die uitvoerende gesag in die onderskeie provinsies moet magtig om 'n munisipaliteit in te stel binne 'n munisipale gebied wat oor 'n provinsiale grens heen strek,

WORD DAAR DERHALWE BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Instel van oorgrensmunisipaliteite

1. Die lede van die Uitvoerende Rade verantwoordelik vir plaaslike regering in die
5 provinsies wat in die eerste kolom van die Bylae aangedui word, word hierby gemagtig om 'n munisipaliteit in te stel in die munisipale gebied vermeld in die tweede kolom van die Bylae teenoor sodanige provinsies.

Herbepaling van grense

2. Die grense van 'n munisipaliteit wat deur hierdie Wet gemagtig is, mag alleenlik
10 herbepaal word onder ander omstandighede as dié waarvoor daar in artikel 90(5) van die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet No. 117 van 1998), voorsiening gemaak word—
(a) met die instemming van die wetgewers van die betrokke provinsies; en
(b) indien die herbepaling deur nasionale wetgewing gemagtig word.
