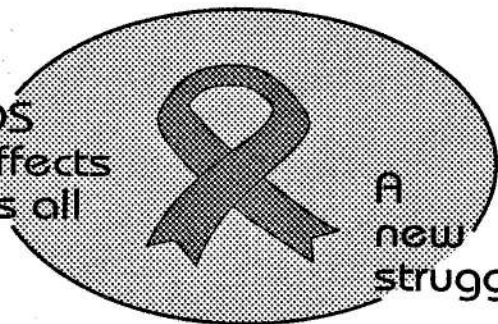

NOTICE 2741 OF 2000

DEPARTMENT OF DEFENCE

PUBLICATION OF EXPLANATORY SUMMARY OF CONVENTIONAL ARMS CONTROL BILL

The Minister of Defence intends introducing the Conventional Arms Control Bill in the National Assembly early in September 2000. The explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Bill Provides for:

The establishment of the National Conventional Arms Control Committee; the objects, functions and composition of the Committee; the provision of a secretariat and an inspectorate to perform the work incidental to the Committee; the control of conventional arms and the authorisation required by individuals for the transfer of arms to a foreign country; the authority of the inspectorate to perform inspections; the definition of offences and the penalties for such offences. The Bill also provides for general matters such as the promulgation of regulations.

PUBLIKASIE VAN 'N VERDUIDELIKENDE OPSOMMING VAN DIE WETSONTWERP OP DIE BEHEER VAN KONVENSIONELE WAPENS

Die Minister van Verdediging is van voorneme om die Wetsontwerp op die Beheer van Konvensionele Wapens in September 2000 by die Algemene Vergadering in te dien. Die verduidelikende opsomming van die wetsontwerp word ooreenkomstig Reël 241(c) van die Algemene Vergadering hiermee gepubliseer.

Die wetsontwerp maak voorsiening vir

Die instelling van die Nasionale Komitee vir die Beheer van Konvensionele Wapens; die doelwitte, funksies en samestelling van die komitee; die voorsiening van 'n sekretariaat en 'n inspektoraat om die bykomstige werk van die komitee uit te voer; die beheer van konvensionele wapens en die magtiging wat deur die individu benodig word om wapens aan 'n vreemde land te verplaas; die bevoegdhede van die inspektoraat om inspeksies uit te voer; die definisie van oortredings en die boetes op sulke oortredings. Die wetsontwerp maak ook voorsiening vir algemene reëlings soos die promulgering van regulasies.
