NOTICE 2921 OF 2000

PUBLICATION OF THE CONSTRUCTION INDUSTRY DEVELOPMENT BOARD BILL AND THE EXPLANATORY SUMMARY THEREOF

The Minister of Public Works intends introducing the Construction Industry Development Board Bill in the National Assembly during September 2000. The explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Construction Industry Development Board Bill provides for:

The establishment of the Construction Industry Development Board; the objects of the Board; the functions, powers of the Board and the delegation of the said powers. The composition of the Board; the members of the Board, their period and conditions of membership; the remuneration and removal of members of the Board; measures regulating the meetings of the Board; the evaluation of the Board and the annual reporting by the Board.

The establishment of a register of contractors, a register of projects, a best practice project assessment scheme and all matters incidental thereto; the funding of the Board and the financial, auditing and reporting controls of the Board. The Bill also provides for all matters incidental to the establishment of a statutory body.
