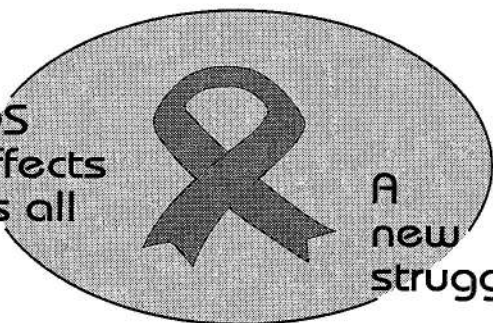

The Competition Commission hereby gives notice, in terms of Rule 26(8)(a)(iii) of the Rules for the Conduct of Proceedings in the Competition Commission, that on 20 September 2000, Bromor Foods (Pty) Ltd, a wholly-owned subsidiary of Cadbury Schweppes South Africa Limited, notified the Competition Commission, in terms of section 13(1) of the Competition Act, No 89 of 1998, of its proposed acquisition of the non-alcoholic beverages division of Stellenbosch Farmers' Winery Limited ("SFW"), a subsidiary of Stellenbosch Farmers' Winery Group Limited ("the Group").

In terms of the proposed transaction, Bromor Foods (Pty) Ltd will acquire the non-alcoholic beverages division of SFW as a going concern.
