State forests or private forests in the area the boundaries of which are indicated in the Schedule hereto, are subject to extraordinary fire hazards and direct that in the said area no person shall from **15 November 2000 up to and including 15 April 2001** make a fire in the open air or, if such a fire has been made, allow it to continue to burn or add fuel thereto, otherwise than -

- (a) fires made within a demarcated picnic or camping area or caravan park or holiday resort, but only at places within such a demarcated area as have been specifically prepared and maintained for that purpose: Provided that such fires are properly extinguished with water and/or sand; and
- (b) fires made on residential and industrial stands within proclaimed townships.

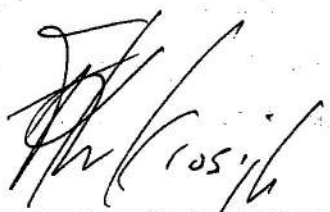
