### **1. NOTICE ON THE APPLICATION FOR TEMPORARY COMMUNITY SOUND BROADCASTING LICENCE**

### **2. THE AUTHORITY'S DECISION REGARDING AN APPLICATION BY RADIO OVERVAAL TO AMEND ITS BROADCASTING LICENCE**

1. The Independent Communications Authority of South Africa gives notice in terms of section 41(6) of the Independent Broadcasting Authority (IBA) Act, No. 153 of 1993, as amended, that an application has been received for a Temporary Community Sound Broadcasting Licence as set out in the Schedule below.

Interested parties are invited to lodge written representations in relation to the application to ICASA at Block D, Pinmill Farm, 164 Kathrine Street, Sandton, Johannesburg OR Private Bag X10002, Sandton, 2146 OR by fax no. (011) 444 – 1461 within fourteen (14) days of the date of publication of this notice.

Persons, who lodge representations in terms hereof, shall at the time of lodgment furnish proof to the satisfaction of the Authority that a copy of the representation has been sent by registered post or delivered to the applicant concerned.

The application and representations received pursuant thereto are open for inspection by interested parties during the normal office hours of the Authority.

2. The Authority further gives notice in terms of section 52 (4) of the IBA Act No 53 of 1993 regarding the amendment of a broadcasting licence of **Overvaal Gemeenskaps Trust**, broadcasting as Radio Overvaal, to increase the effective radiated power (**ERP**) of its transmission from **200W to 5000W**. The application was published in the government gazette No: 2083 of 26 May 2000. A hearing on the application was held on 14 September 2000 at ICASA's premises.

The Authority decided to grant the application as applied for i.e. an effective radiated power of **5000W**.

The effective date of the amendment is 21 November 2000.
