NOTICE OF PROPOSED ACQUISITION OF AMPROS (PTY) LTD AND ANGLO AMERICAN PROPERTIES LIMITED BY APEX PROPERTIES (PTY) LIMITED

The Competition Commission hereby gives notice, in terms of Rule 26(8)(a)(iii) of the Rules for the Conduct of Proceedings in the Competition Commission, that on 29 November 2000, Apex Properties (Pty) Ltd ("ApexHi"), notified the Competition Commission, in terms of section 13(1) of the Competition Act, No 89 of 1998, of its proposed acquisition of Ampros (Pty) Ltd ("AMPROS") and Anglo American Properties Limited ("AMAPROP"). AMPROS and AMAPROP are wholly owned subsidiaries of Anglo South Africa (Pty) Ltd, which, in turn, is a wholly owned subsidiary of Anglo American plc.

In terms of the proposed transaction, ApexHi will acquire the businesses of AMPROS and AMAPROP. ApexHi has previously not traded, while both AMPROS and AMAPROP are in the business of developing, investing in and leasing out commercial properties.

The Competition Commission is currently assessing and evaluating the transaction in terms of the Competition Act, 89 of 1998. Any person may voluntarily file any document, affidavit, statement of his/her views with respect to the merger, or other relevant information, with the Commission.
