### NOTICE 450 OF 2001

## The Councils for the Built Environment Professions

### Call for Nominations for Members of the Public to be appointed as Members to the South African Council of Project and Construction Management Professions

**Closing date: 26 April 2001**

In terms of the Project and Construction Management Profession Act, 2000 (Act No. 48 of 2000) I, Stella N. Sigcau, the Minister of Public Works, hereby call for nominations from members of the general public to the South African Council for the Project and Construction Management Professions.

#### BACKGROUND

In December 2000, the President assented to legislation providing for the establishment of the council for the profession of project and construction management. This is a new council which will be established in July 2001. This council will: register professionals and candidates within this profession, uphold professional conduct, identify functions of each category of this profession, recommend professional fees, and promote regional and international recognition of the professions.

The Council will consist of 8 members, 2 of which will be members of the public. The period of office for the members is 4 years.

Each nomination must be in writing and must contain the following information-

- (a) The name and address of the nominating person or organisation;
- (b) The name, address and identity number of the nominee;
- (c) A signed declaration by the nominee that he or she is prepared to serve on the Council or/and any of its committees and is not disqualified from serving on the Council\*\*
- (d) Motivation for the appointment of the nominee to the Council (not exceeding one page)
- (e) A short curriculum vitae of the nominee (not exceeding two pages)

Nominations should reach the Department of Public Works at the addresses below not later than 26 April 2001. No late submissions will be accepted. Nominations must be sent to: The Director-General, National Department of Public Works, Private Bag X65, Pretoria, 001 marked for the attention of Ms. L. Mabuntana, Room A520, Central Government Offices, Tel. (012) 337 2859.

#### PLEASE NOTE

\*\*Non-citizens, unrehabilitated insolvents, persons convicted of serious offences (excluding political offences), persons found guilty of improper conduct and persons removed from an office of trust are not qualified to serve as members of the Council.
