#### AMENDMENT TO DETERMINATION OF THRESHOLD

I, Alexander Erwin, Minister of Trade and Industry, do hereby in terms of section 6 (1) of the Competition Act, 1998 (Act No. 89 of 1998), in consultation with the Competition Commission amend the Schedule to General Notice No. 253 of 1 February 2001 by—

- (1) Substituting the number "6" for the number "11" in line one of item 1; and
  - (2) Substituting the number "6" for the number "11" in line one of item 2 (1).

#### NOTICE OF PROPOSED AMENDMENT TO DETERMINATION OF THRESHOLD

I, Alexander Erwin, Minister of Trade and Industry, do hereby give notice in terms of section 11 (3) of the Competition Act, 1998 (Act No. 89 of 1998) ("the Act"), in consultation with the Competition Commission of my intention in terms of section 11 (1) of the Act to amend General Notice, 254 of 1 February 2001 ("the Notice") by—

- (1) The insertion of the following item after item (6) of the Determination of Threshold:

"(7) In this Determination of Threshold "transferred firm" means—

- (a) a firm, or the business or assets of a firm, that as a result of a transaction in any circumstances set out in section 12, would become directly or indirectly controlled by an acquiring firm; and
- (b) any other firm, or the business or assets of a firm, the whole or part of whose business is directly or indirectly controlled by a firm contemplated in paragraph (a)."; and

- (2) Substituting the word "transferred" for the word "target" wherever it appears in the Notice.

Any person who wishes to make submissions regarding the proposed amendment must do so in writing within 14 days of date of this notice.
