PUBLICATION OF EXPLANATORY SUMMARY
OF THE SUPREME COURT DECREE, 1990
(CISKEI) AMENDMENT BILL, 2001

The Minister for Justice and Constitutional Development intends introducing the Supreme Court Decree (Ciskei) Bill, 2001, in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Bill makes provision for the amendment of the Supreme Court Decree, 1990 (Ciskei), so as to enable the High Court seated at Bisho to sit at any place in the province of the Eastern Cape; and for matters connected therewith.
