THE LAW SOCIETY OF THE TRANSVAAL**AMENDMENT OF RULES**

It is hereby notified that the following amendments to the Rules framed in terms of Section 74(1) of Act No. 53 of 1979 and which have been approved by the Chief Justice of South Africa in consultation with the Judge President of the Transvaal in terms of Section 74(2) of Act No. 53 of 1979, are promulgated by the Council of the Law Society of the Transvaal:

1. **Rule 30A.**

The period of validity of rule 30A is extended until 30 June 2004.

2. **Rule 30.1.**

The suspension of rule 30.1 shall be extended from 30 June 1999 until 30 June 2004, whereafter it shall again be of full force and effect.

3. **Rules 30.2, 31 up to and including rule 42 and rule 47.3.**

The suspension of rules 30.2, 31 up to and including rule 42, and rule 47.3 is extended from 30 June 1999 until 30 June 2002, except if these rules are duly amended before the latter date, whereafter it shall again be of full force and effect.

4. **Rule 47.4.**

The suspension of rule 47.4 is extended until 30 June 2004, whereafter it shall again be of full force and effect.

5. **Rules 47.6 and 47.7.**

The period of validity of rules 47.6 and 47.7 is extended until 30 June 2004, whereafter they shall be of no further force and effect.

6. **Rule 80.4.4.**

The following new rule is adopted in the place of the existing rule:

As soon as the council or the committee, as the case may be, has arrived at its decision, it shall deliver to both the member and such person either by hand or prepaid registered post, a copy of the fee list submitted for assessment, duly endorsed with the allocatur of the council or the committee, as the case may be, under the hand of the secretary.

7. **Rule 80.4.4A.**

The entire rule should be deleted.

8. **Rule 95A.2**

The following new rule is adopted in the place of the existing rule:

Where the committee consists of three or more members, two members will form a quorum : provided that where the Committee consists of three or more members, any decision made or order granted must in such event be made or granted by way of a majority decision.

Date of Commencement.

These amended rules will come into operation on the date of publication thereof in the Government Gazette.

PROKUREURSORDE VAN TRANSVAAL

WYSIGING VAN REËLS

Hiermee word kennis gegee dat die volgende wysigings in die Reëls opgestel kragtens Artikel 74(1) van Wet No. 53 van 1979 en wat deur die Hoofregter van Suid-Afrika in oorleg met die Regter-President van Transvaal goedgekeur is ingevolge Artikel 74(2) van Wet No. 53 van 1979, deur die Raad van die Prokureursorde van Transvaal uitgevaardig word:

1. **Reël 30A.**

Die geldigheid van reël 30A word verleng tot 30 Junie 2004.

2. **Reël 30.1.**

Die opskorting van reël 30.1 word verleng van 30 Junie 1999 tot 30 Junie 2004, waarna daardie reël weer volle werking en gevolg sal hê.

3. **Reëls 30.2, 31 tot en met reël 42 en reël 47.3**

Die opskorting van reëls 30.2, 31 tot en met reël 42, en reël 47.3 word verleng van 30 Junie 1999 tot 30 Junie 2004, tensy hierdie reëls voor laasgenoemde datum behoorlik gewysig word, by gebreke waaraan hierdie reëls weer volle werking en gevolg sal hê.

4. **Reël 47.4.**

Die opskorting van reël 47.4 word verleng tot 30 Junie 2004, waarna die reël weer volle werking en gevolg sal hê.

5. **Reëls 47.6 en 47.7.**

Die geldigheidsduur van reëls 47.6 and 47.7 word verleng tot 30 Junie 2004, waarna hierdie reëls geen werking of gevolg sal hê nie.

6. **Reël 80.4.4.**

Reël 80.4.4. word vervang met die volgende nuwe reël:

Sodra die raad of die komitee, na gelang van die geval, tot 'n besluit geraak het, moet hy aan beide die lid en sodanige persoon of per hand of per vooruitbetaalde geregistreeerde pos 'n afskrif lewer van die geldelys wat voorgelê is vir berekening met die allocatur van die raad of komitee, na gelang van die geval, behoorlik onder handtekening van die sekretaris daarop geëndosseer.

7. **Reël 80.4.4A.**

Die reël moet in geheel deurgehaal word.

8. **Reël 95A.2.**

Reël 95A.2 word vervang met die volgende nuwe reël.

Waar die komitee uit drie of meer lede bestaan, vorm twee lede wat teenwoordig is 'n kworum : met dien verstande dat waar die komitee uit drie of meer lede bestaan, enige beslissing of bevel in so 'n geval by wyse van 'n meerderheidsbesluit gemaak moet word.

Datum van Inwerkingtreding.

Hierdie gewysigde reëls tree in werking op die datum waarop hulle in die Staatskoerant gepubliseer word.
