NOTICE OF EXTENSION OF TIME FOR REGISTRATION OF WATER USES IN TERMS OF THE NATIONAL WATER ACT, 1998

Kindly take notice that the period for the registration of a water use in terms of the National Water Act, 1998 (Act No 36 of 1998) is extended to 30 June 2001.

Failure to register a water use or failure to timeously submit additional information within the extended period shall in terms of regulation 12 of R1352 dated 12 November 2001 subject the water user to a late registration fee as follows:

1. An administration fee equivalent to the amount of water use charge outstanding at the date of registration; and
2. R300, 00 (three hundred Rand) OR 10% (ten percent) of the annual water use charges outstanding at the date of registration, **whichever is the greater.**

Action will also be proceeded with in terms of section 54 of the National Water Act, 1998 to suspend or withdraw any water use entitlement not registered.

Any person who registers within the aforementioned extended period will not be charged a late registration fee nor will any action be proceeded with against them in terms of section 54 of the National Water Act, 1998.

**VERLENGING VAN DIE PERIODE OM 'N WATERGEBRUIK TE
REGISTREER INGEVOLGE VAN DIE NASIONALE WATERWET, 1998**

Geliewe kennis te neem dat die tydperk om 'n watergebruik ingevolge die Nasionale Waterwet, 1998 (Wet No. 36 van 1998) te registreer uitgestel is tot 30 Junie 2001.

Versuim om 'n watergebruik te registreer, of versuim om betyds enige verdere inligting te verskaf, sal kragtens regulasie 12 van R1352 gedateer 12 November 2001, die watergebruiker soos volg aan 'n laat registrasiefooi, blootstel:

1. 'n Administrasiefooi gelykstaande aan die bedrag van die watergebruikvordering uitstaande op die datum van registrasie; en
2. R300, 00 (drie hondred rand) OF 10% (tien persent) van die jaarlikse watergebruikvordering uitstaande op die datum van registrasie, **welke ookal die grootste is.**

Optrede vir die opskorting of intrekking van enige watergebruiker wat nie geregistreer is nie, sal ook kragtens artikel 54 van die Nasionale Waterwet, 1998 geneem word

Enige persoon wat gedurende die bogenoemde verlengingstydperk registreer, sal nie vir die laat registrasiefooi aanspreeklik wees nie, en geen optrede sal teen hulle kragtens artikel 54 van die Nasionale Waterwet, 1998 geneem word, nie
