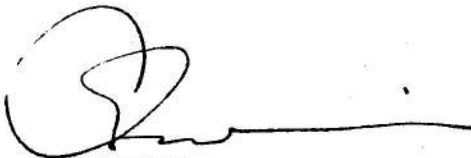
DEPARTMENT OF TRADE AND INDUSTRY NOTICE IN TERMS OF SECTION 23 OF THE COUNTERFEIT GOODS ACT, 1997 (ACT NO 37 OF 1997)

I, Alexander Erwin, Minister of Trade and Industry, do hereby:

1. in terms of section 23(1) and 23(2) of the Counterfeit Goods Act, 1997 (Act No 37 of 1997), designate for the purposes of this Act the following warehouse facilities as counterfeit goods depots on a self-funding basis and appoint the following persons in charge of the depots:
