BASIC CONDITIONS OF EMPLOYMENT ACT, 1997

MINISTERIAL DETERMINATION: WELFARE SECTOR, SOUTH AFRICA

I, Membathisi Mphumzi Shepherd Mdladlana, Minister of Labour, hereby in terms of section 50 of the Basic Conditions of Employment Act, 1997, make a Ministerial Determination establishing conditions of employment for employers and employees in the Welfare Sector, South Africa, in the Schedule hereto and determine the date of publication of this notice as the date from which the provisions of the said Ministerial Determination shall become binding.

1. Definitions

- 1.1 In this determination
 - "welfare sector" means employers, excluding the state as an employer, who render non-profit social services in South Africa.
- 1.2 "working time" means time actually worked excluding standby periods.

2. Application

- 2.1 This determination applies to all employers and employees engaged in the welfare sector.
- 2.2 To the extent provided for in this determination, this determination varies the application of the Basic Conditions of Employment Act, No. 75 of 1997, to such employers and their employees.
- Unless otherwise indicated, any word used in this determination has the same meaning as in the Basic Conditions of Employment Act, No. 75 of 1997.

3. Overtime

- 3.1 Despite section 10(1)(b)(ii) of the Basic Conditions of Employment Act, No. 75 of 1997, an employer may not require or permit an employee to work more than fifteen hours overtime in a week.
- 3.2 An agreement may provide for an employer to pay the ordinary wage for overtime worked and grant an additional weeks leave on full pay per annum.

4. Averaging of hours

- Despite sections (9)(1) and (2) and 10(1)(b) of the Basic Conditions of Employment Act, No. 75 of 1997 and clause 3 of this determination, the ordinary hours of work and overtime of an employee may be averaged over a period of up to four months in terms of a written agreement concluded by an employer and an employee.
- 4.2 An employer may not require or permit an employee who is bound by an agreement in terms of sub-clause 1 to work more than—
 - an average of forty-five ordinary hours of work in a week over the agreed period;
 - (b) an average of ten hours overtime in a week over the agreed period.
- 4.3 An agreement in terms of sub-clause (1) lapses after twelve (12) months.
- 4.4 Sub-clause (3) only applies to the first two agreements concluded in terms of sub-clause (1).

5. Pay for work on Sundays

- Despite section 16(1) of the Basic Conditions of Employment Act, No. 75 of 1997, an employer must pay an employee who works on Sunday the normal wage for each hour worked and be granted extra leave as follows:
 - employees who ordinarily work on a Sunday who work on average one Sunday per month be granted three additional days leave on full pay per annum;
 - (b) employees who ordinarily work on a Sunday who work on average two Sundays per month be granted six additional days leave on full pay per annum.

6. Night work

Despite section 17(2)(a) of the Basic Conditions of Employment Act, No. 75 of 1997, an agreement in writing may permit an employee to waive his/her right to any payment of an allowance if the employee voluntary request or prefer to work night shifts.

7. Standby employees

7.1 Employees who are regularly required to be on standby must be granted one additional week's leave per annum.

RULES RELATING TO CONTINUING PROFESSIONAL DEVELOPMENT IN MEDICAL TECHNOLOGY

The Health Professions Council of South Africa intends, in terms of section 26 read with section 15B of the Health Professions Act, 1974 (Act No. 56 of 1974), to make the rules set out in the Schedule.

Interested persons are invited to submit any substantiated comments or representations on the proposed rules to the Registrar, P.O. Box 205, Pretoria, 0001 (for the attention of the Secretary: Professional Board for Medical Technology), within one month of the date of publication of this notice.

SCHEDULE

DEFINITIONS

- 1. In these rules "the Act" means the Health Professions Act, 1974 (Act No. 56 of 1974), and, unless inconsistent with the context—
 - "board" means the Professional Board for Medical Technology established by *Government Notice* No. R. 75 of 16 January 1998;
 - "continuing professional development" means the continuing education and training referred to in section 26 of the Act and prescribed in terms of these rules.

REQUIREMENTS

- 2. Any medical technologist, medical technician or supplementary medical technician whose name on 1 April 2002 appears on the register of medical technologists, medical technicians or supplementary medical technicians kept in terms of section 18 of the Act, shall be required to comply with the conditions of continuing professional development laid down in these rules from the following year which shall be a prerequisite for such medical technologist, medical technician or supplementary medical technician to retain his or her registration in terms of the Act.
- 3. Any person who, after 1 April 2002, registers for the first time in terms of the Act as a medical technologist, medical technician or supplementary medical technician in any category of independent practice or public service, shall be required to comply with the conditions of continuing professional development laid down in these rules from the following year, which shall be a reprequisite for such medical technologist, medical technician or supplementary medical technician to retain his or her registration in terms of the Act.
- 4. Any person whose name had been erased from the register of medical technologists, medical technicians or supplementary medical technicians shall be subject to compliance with any condition (s) which the board may specify prior to the restoration of the name of such practitioner to the relevant register.

- For the purpose of continuing professional development, every medical technologist, medical technician or supplementary medical technician shall, as from 1 April 2002, be required to accumulate at least 50 points within any one year on the following basis:
 - (1) a minimum of 25 points shall be accumulated in any one year:
- (2) a maximum of 75 points shall be accumulated in any one year, provided that any points accumulated during one year in excess of 50 points may be forwarded to the subsequent year only:

Provided that, if the medical technologist, medical technician or supplementary medical technician does not accumulate the prescribed minimum of 25 in any one year, he or she shall be permitted to obtain the required points in the subsequent year.

- The 50 points prescribed in rule 5 shall be accumulated by way of different educational or developmental activities accredited by the board in any of the following categories of activities:
 - Organisational activities:
 - small-group activities; (2)
 - (3) individual activities;

- any other activities or category of activities which the board may accredit from time to time.
- In complying with the requirements no more than eighty 80% of points may be obtained in any one category.
- In complying with the requirements, at least one point per annum shall have to be obtained by every practitioner in professional ethics.
 - 8.2 During any one year a maximum of 5 points may be obtained in other health related activities.
- Deferment of compliance with the requirements of continuing professional development may only be granted by the board on application to individual practitioners on submission of adequate reasons and subject to such requirements as the board may determine.
- In the event of a medical technologist, medical technician or supplementary medical technician not complying with the conditions specified in these rules within the prescribed period of time, the board may impose any one or more of the following conditions, namely:
 - (a) grant the medical technologist, medical technician or supplementary medical technician deferment;
 - (b) require the medical technologist, medical technician or supplementary medical technician to follow a remedial programme of continuing education and training as specified by the board;
 - require the medical technologist, medical technician or supplementary medical technician to write an examination as determined by the board;
 - register the medical technologist, medical technician or supplementary medical technician in a category of registration which will provide for supervision regarded as appropriate by the board;
 - erase the name of the medical technologist, medical technician or supplementary medical technician from the relevant register;
 - register the medical technologist, medical technician or supplementary medical technician in a category of registration which will provide for non-clinical registration.






