ACT

To appropriate amounts of money for the requirements of the State in respect of the financial year ending 31 March 2002.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Appropriation of amounts of money for requirements of State

1. Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there are hereby appropriated out of the National Revenue Fund for the requirements of the State in respect of the financial year ending 31 March 2002, the amounts of money as set out in column 1 of the Schedule under the heading "Vote". 5

2. This Act is called the Appropriation Act, 2001.
