COUNTERFEIT GOODS ACT, 1997 (ACT No. 37 OF 1997)

- It is hereby made known for general information and comment that consideration is being given, for the purposes
 of the Counterfeit Goods Act, 1997 (Act No. 37 of 1997), to the possible:
 - (a) designation of the following warehouse facilities as counterfeit goods depots on a self-funding basis and

- Note should be taken of the provisions of sections 8, 9 and 17 of the Act regarding the responsibilities of the person designated to be in charge of the depot, the liability for damage or loss arising pursuant to the application of the Act and the general safekeeping requirements at the depot.
