### NOTICE 1817 OF 2001

#### DEPARTMENT OF TRADE AND INDUSTRY

#### COUNTERFEIT GOODS ACT, 1997 (ACT No. 37 OF 1997)

1. It is hereby made known for general information and comment that consideration is being given, for the purposes of the Counterfeit Goods Act, 1997 (Act No. 37 of 1997), to the possible:

- (a) designation of the following warehouse facilities as counterfeit goods depots on a self-funding basis and

2. Interested parties are invited to:

- (a) comment on the possible designation of the above-mentioned warehouse facilities as counterfeit goods depots and the appointment of the persons in charge thereof within 14 days of the date of this publication and;
- (b) apply for warehouse facilities to be designated as counterfeit goods depots on a self-funding basis.

3. Note should be taken of the provisions of sections 8, 9 and 17 of the Act regarding the responsibilities of the person designated to be in charge of the depot, the liability for damage or loss arising pursuant to the application of the Act and the general safekeeping requirements at the depot.
