**PUBLICATION OF EXPLANATORY SUMMARY OF LAND AND AGRICULTURAL
DEVELOPMENT BANK BILL**

The Minister of Agriculture and Land Affairs intends introducing the Land and Agricultural Development Bank Bill in the National Assembly during September 2001. An explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Bill addresses the following:

To provide for a juristic person known as the Land and Agricultural Development Bank; to provide for the mandate of the Bank; to provide for governance of the Bank; to regulate the management and control of the Bank; to provide for the funding of the Bank; to provide for the business of the Bank; to provide for risk management of the Bank; and to provide for connected matters.
