### NOTICE 2114 OF 2001

### NOTICE IN TERMS OF S62 (7) OF THE LABOUR RELATIONS ACT 66 OF 1995

Interested and affected parties are advised that a demarcation dispute has been referred to the Commission for Conciliation Mediation and Arbitration [reference KN349-01] and that the Commission for Conciliation Mediation and Arbitration believes it to be a question of substantial importance, requiring the publication of this notice.

The present parties to the dispute are: the Bargaining Council for the Textile Manufacturing Industry of South Africa; the Motor Industry Bargaining Council (Natal Region); South African Clothing and Textile Workers' Union; and Feltex Automotive Trim.

The demarcation dispute arises from:-

- a) the inclusion in the definition of the Motor Industry of the following words: "the business of manufacturing establishments in which motor vehicle parts and/or spares and/or accessories and/or components thereof are fabricated", and;
- b) the inclusion in the definition of Textile Industry of the following words: "the Non-Woven Products Sub-Sector, which means the joint enterprise in which employers and their employees are associated for the purpose of the manufacture of non-woven products including but not limited to flock, wadding, padding, felt, underfelt, medical wadding, cotton wool and needlepunched, stitch-bonded, spun-bonded, chemically bonded or thermo-bonded textile fibre materials by any process whatsoever, including all operations incidental thereto and consequential thereon in the course of such manufacture."
