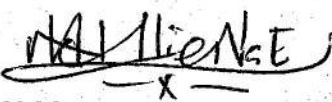

BY-PASS TO THE EXISTING PROCLAIMED TOLL ROAD AT THE KROONSTAD
NORTH INTERCHANGE AS A TOLL ROAD**

In terms of Section 27 (1)(a)(i) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act No 7 of 1998), the Agency hereby declares that section of National Route 1 from just south of the Sydenham Interchange at approximately kilometre 28,0 on section 15 in the Bloemfontein area up to the start of the existing toll road at Kroonstad at kilometre 75,4 (N1 section 17), as declared by Government Notices 144 of 1979, 236 of 1972, 167 of 1993, 253 of 1975, 3 of 1984, 73 of 1979 and 124 of 1985, as a Toll road.

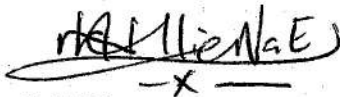

**NOTICE OF INTENTION TO DECLARE JOHN ROSS HIGHWAY A TOLL ROAD
AND ERECT A TOLL PLAZA.**

In terms of Section 27(4)(a) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act No 7 of 1998), the South African National Roads Agency hereby gives notice of its intention to recommend to the Minister of Transport to declare the John Ross Highway as declared a National Route by Government Notice 1037 of 11 October 2001 to be a Toll Road. In terms of section 27(4)(a)(i) of the said Act the approximate position of the proposed toll plaza is indicated in the annexure attached hereto.

In terms of section 27(4)(a)(ii) of the said Act interested persons are hereby invited to furnish written comments and representations to the South African National Roads Agency Limited, Eastern Region, P O Box 100410, Scottsville 3209, for the attention of the Regional Manager, on the proposed declaration including the position of the Toll Plaza. Written comment and representations should be furnished on or before 21 December 2001.

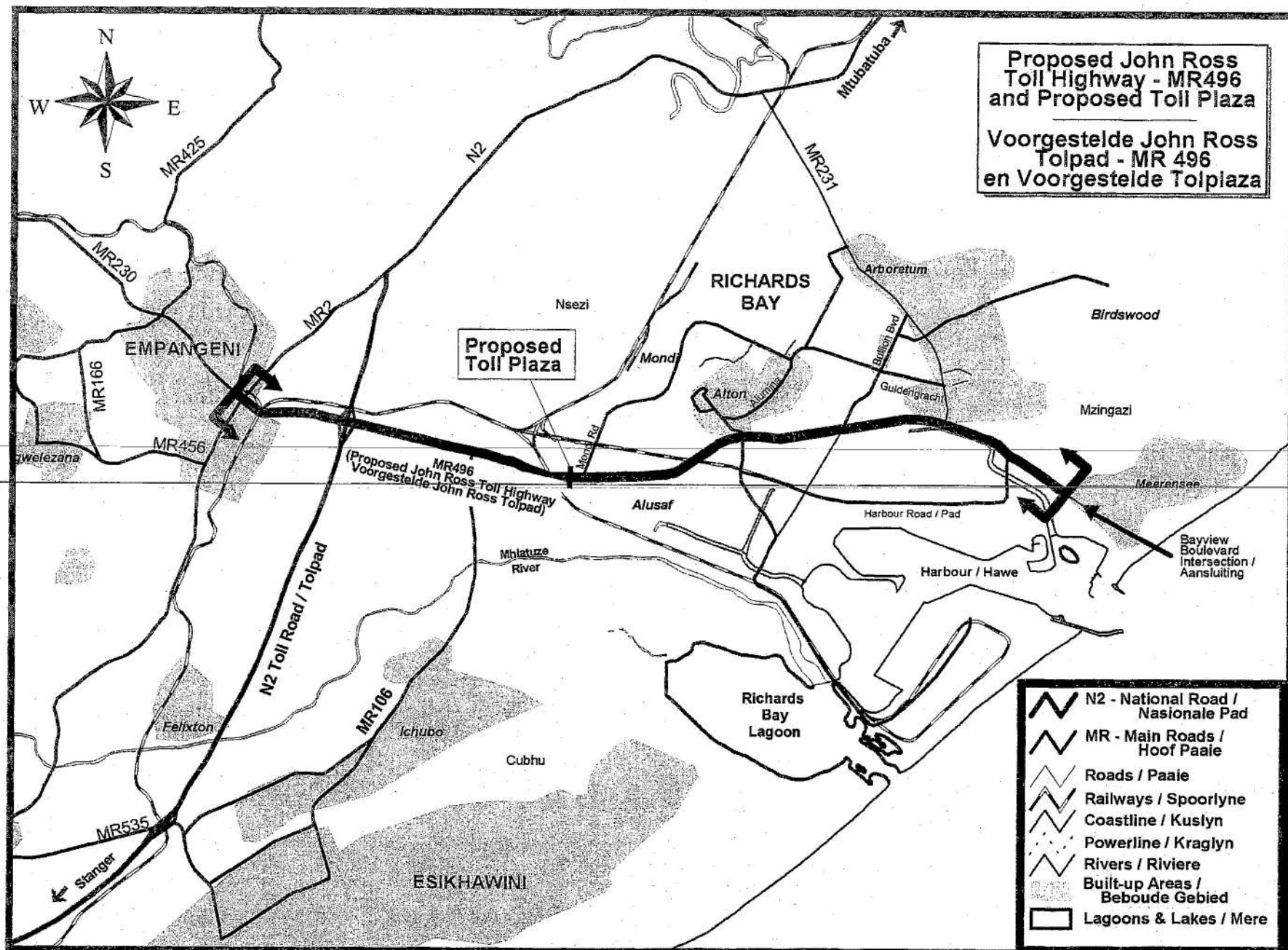
