

- (iii) Specified motor vehicles defined in Note 7(b) manufactured under the rebate item and exported by the manufacturer from the licensed premises without engines and/or gearboxes fitted to the vehicles when exported and motor vehicles fitted with a fibreglass body. Such vehicles will be regarded as components for purposes of claiming Import Rebate Credit Certificates;
- (iv) Automotive components and automotive tooling as defined in Note 10 for which a certificate was issued by the Director-General: Trade and Industry on the recommendation of the Board on Tariffs and Trade that the export of such components and tooling contribute to the achievement of the overall objectives of the Government's Motor Industry Development Programme.

Such components and tooling shall, furthermore, meet the following criteria, namely that -

- (c) They were wholly or partly manufactured in the common customs area;
- (d) not less than 25 per cent of the ex-factory selling price of the components and tooling is represented by the sum of:
  - the cost of labour in the common customs area;
  - the value of materials of the common customs area;

- the factory overhead expenses (excluding profit) incurred in the common customs area in respect of components and tooling; and
- (e) the final process of manufacture is undertaken in the common customs area: Provided that operations of packaging or painting shall not qualify as manufacturing processes. In the event of final process of manufacture not taking place in the common customs area, a determination as to the eligibility of the relevant product must be made by the Board on Tariffs and Trade,".

B. Amendment of Note 7(iii) to rebate item 317.04 to read as follows:

"7. "Specified motor vehicles" means -

- (iii)(a) motor cars (including station wagons) fitted with engines and gearboxes of heading No.87.03;
- (iii)(b) motor cars (including station wagons) not fitted with engines and/or gearboxes and motor vehicles fitted with fibreglass bodies of heading No. 87.03;".

C. Amendment of Note 1(i) and (ii) to rebate item 460.17/8701.20/01.06, 460.17/87.02/01.04, 460.17/87.03/01.04, 460.17/870.04/01.04 and 460.17/87.06/01.04 to read as follows:

1. For the purposes of this rebate the extent of rebate "not exceeding the duty as calculated in terms of the notes to this rebate item" means the customs duty payable must be calculated on a value determined as follows:
  - (i) The value for customs duty purposes of motor vehicles imported less the value of any excess duty free allowance as calculated in the quarterly account of a manufacturer of specified motor vehicles (as defined in Note 7 to rebate item 317.04) and less the value of an import rebate credit certificate in respect of motor vehicles, provided for in this rebate item, automotive components and automotive tooling exported.



- (ii) For the purposes of paragraph (i) above the value of the excess duty free allowance and the value of an import rebate credit certificate shall be reduced by 30 per cent if the rebate is used to import specified motor vehicles. No adjustment shall, however, be made if the import rebate credit is in respect of specified motor vehicles exported with engines and gearboxes fitted at the time of export."

D. Amendment of the note to refund item 537.00 to read as follows:

**Note:**

The value of import rebate credit certificates in respect of light motor vehicles exported without an engine and/or a gearbox, motor vehicles fitted with fibreglass bodies, eligible export components, automotive tooling and motor vehicles manufactured under rebate item 317.07 exported shall be reduced by 30 per cent

[Note: Light motor vehicles, whether they are fitted with engines and/or gearboxes or not, are in general classified as built-up light motor vehicles by SARS and these exports are incentivised more than component exports under the MIDP, although most light motor vehicles are fitted with imported engines and gearboxes.

There is a concern that the method of exporting vehicles without an engine and/or gearbox may increase significantly, or that more components will not be fitted to the vehicles exported. This may impact on employment and investment levels and may also affect the fitment of "hang-on" engine and gearbox parts such as hoses, oil, fuel and air filters, and pumps, etc.

More and more of the smaller vehicle manufacturers that produce niche vehicles mainly for the export market, do not fit engines and gearboxes to such vehicles. However, this method of exporting is being explored more and more by the larger vehicle assemblers, which have recently gained large export orders or which are exploring such exports.

The smaller light motor vehicle manufacturers producing niche vehicles mostly fit fibreglass bodies to such vehicles. The investment required to manufacture fibreglass bodies is much less than that required to manufacture metal bodies. It is of concern that IRCCs are issued for the local content of light motor vehicles fitted with fibreglass bodies which are then used for the importation of light motor vehicles fitted with metal bodies, without any adjustment to the value of the IRCC.

A preventative measure to address this issue is under investigation to curb any further disassembly of light motor vehicle exports and to address the ratio of IRCCs issued for the local content of exported light motor vehicles fitted with fibreglass bodies against the imports of CBU light motor vehicles fitted with metal bodies.]
