CONSTITUTIONAL DEVELOPMENT****PUBLICATION OF EXPLANATORY SUMMARY OF THE
REINSTATEMENT OF ENROLMENT OF CERTAIN LEGAL
PRACTITIONERS BILL, 2002**

The Minister for Justice and Constitutional Development intends introducing the Reinstatement of Enrolment of Certain Legal Practitioners Bill, 2002, in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Bill makes provision for the reinstatement of the enrolment of legal practitioners who were struck off the roll of advocates or attorneys as a result of their opposition to the political dispensation of apartheid and who are deceased. An application for reinstatement may be brought before the High Court by—

- a member of the person's family;
- the General Council of the Bar of South Africa;
- the Bar Council concerned;
- the Society of Advocates concerned;
- the Law Society of South Africa;
- the law society concerned; or
- any other interested person.

Die verduidelikende opsomming van die Wetsontwerp word hierby ooreenkomstig Reël 241(c) van die Reëls van die Nasionale Vergadering gepubliseer.

Die Wetsontwerp maak voorsiening vir die herstel van die inskrywing van regspraktisyns wat van die rol van advokate of prokureurs geskrap is as gevolg van hul verset teen die staatkundige bedeling van apartheid en wat oorlede is. 'n Aansoek vir herstel kan voor 'n Hoë Hof gebring word deur—

- 'n lid van die persoon se familie;
- die Algemene Balieraad van Suid-Afrika;
- die betrokke Balieraad;
- die betrokke Vereniging van Advokate;
- die Prokureursorde van Suid-Afrika;
- die betrokke prokureursorde; of
- enige ander persoon wat 'n belang daarby het.
