

NOTICE OF EXCLUSION/EXEMPTION FROM THE REPORTING OBLIGATIONS AS REQUIRED IN THE CHART OF ACCOUNTS AND COST ALLOCATION MANUAL

The Independent Communications Authority of South Africa (ICASA) hereby gives notice to the public of its intention to exclude until further notice certain holders of licences issued in terms of section 34(2), section 39 and section 40A of the Telecommunications Act 103 of 1996, as amended, from the reporting obligations described in the **Chart of Accounts and Cost Allocation Manual (COA/CAM)** issued by ICASA pursuant to section 46 of the Telecommunications Act 103 of 1996, as amended.

The following licensees, and potential licensees, are excluded and/or exempted from the reporting requirements set out in the COA/CAM, until further notice.

- Cell C (Pty) Ltd
- Sentech (Pty) Ltd
- Second national operator
- All licensees issued under section 39 of the Telecommunications Act 103 of 1996, as amended
- All licensees issued under section 40A of the Telecommunications Act 103 of 1996, as amended

The following Mobile Cellular Telecommunications Service Licence holders shall continue to report under the existing arrangements as provided by Volume 2 of the COA/CAM, and are therefore excluded from the reporting obligations described in Volume 1 of the COA/CAM, until such time as Volume 2 is updated in terms of section 46 of the Telecommunications Act 103 of 1996, as amended:
