NOTICE 319 OF 2002

GENERAL NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT No. 22 OF 1994), as amended.

Notice is hereby given in terms of Section 11(1) of the Restitution of Land Rights Act, 1994 (Act No. 22 of 1994), as amended, that a claim for the restitution of land rights has been submitted to the Regional Land Claims Commissioner for the Western Cape. The particulars regarding this claim are as follows:

Area : Malmesbury town in the magisterial district of Malmesbury Western Cape

Date submitted : 1998/11/04

Compensation : Financial Compensation

The Claim : A group of 36 (thirty-six) claimants who were removed from the town of Malmesbury have lodged individual claims for loss of tenancy rights. The claimants were tenants on various erven in Malmesbury. A list of the erven is available from the Commission on the Restitution of Land Rights.
