PROVISIONAL PROTECTION AS A HERITAGE RESOURCE

By virtue of the powers vested in the South African Heritage Resources Agency in terms of section 29 (1) of the National Heritage Resources Act, No. 25 of 1999 (the Act), read with section 29 (1) (a) (iii) of the Act, the property as fully described in the Schedule hereto is hereby provisionally protected as a heritage resource for a period of two years.

Description: The property known as the site of the 1960 massacre in Sharpeville, situated on unregistered municipal land known as Erven 9170, 9171, 9172, 9175 and 9176, in the Sharpeville Township, in the Vereeniging District, Gauteng.
