NOTICE OF THE APPLICATION BY THE SOUTH AFRICAN BROADCASTING CORPORATION (SABC) TO AMEND ITS BROADCASTING LICENCE FOR MUGHANA LONENE FM

The Independent Communications Authority of South Africa hereby gives notice that it has received an application by the SABC to amend its broadcasting licence in respect of Mughana Lonene FM. The application was lodged in terms of section 52 (1) (a) of the Independent Broadcasting Authority Act, Act 153 of 1993 as amended.

The applicant seeks to change the frequency of Mughana Lonene transmitter at Louis Trichardt from **88.8 MHz to 90.0 MHz**, all other specifications at the site remaining the same, i.e ERP – 3kW; Antenna Horizontal Radiated pattern – Directional. The applicant indicates that the cause for the proposed change is that the frequency (88.8MHz) of Mughana Lonene at Louis Trichardt mixes with other frequencies to produce intermodulation products which cause interference to aeronautical communication system operating on frequency 119.8 MHz at the same site and that this would have an impact of the safety of people's lives.

The Independent Communications Authority of South Africa hereby gives notice that it has received an application by the SABC to amend its broadcasting licence in respect of Mughana Lonene FM. The application was lodged in terms of section 52 (1) (a) of the Independent Broadcasting Authority Act, Act 153 of 1993 as amended.

The applicant seeks to increase the ERP of Mughana Lonene at frequency 90.0 MHz from 3KW to 33KW by making alterations to the antenna to include the service, Mughana Lonene, on the main omni-directional antenna. This would result in incidental over spilling into Zimbabwe.
