GENERAL NOTICE**NOTICE 889 OF 2002****DEPARTMENT OF TRADE AND INDUSTRY****PROMULGATION BY THE MINISTER OF TRADE AND INDUSTRY OF PERCENTAGES OF MONEY TO BE ALLOCATED
IN TERMS OF SECTION 26 (3) OF THE LOTTERIES ACT, 1997 (ACT NO. 57 OF 1997)**

I, Alec Erwin, Minister of Trade and Industry, hereby determine **31 May 2002** as the date on which the following percentages of money to be allocated in terms of section 26 (3) of the National Lotteries Act, 1997 (Act No. 57 of 1997), shall come into operation.

Percentages in respect of allocation of funds [section 26 (1)]:

(b) The balance in the fund as contemplated in section 26 (3) of the Act, shall be allocated as follows:

- (1) For expenditure on or connected with reconstruction and development projects and other programmes referred to in the Reconstruction and Development Programme Fund Act, 1994 (Act No. 7 of 1994), fifteen (15) percent;
- (2) for charitable expenditure, thirty-six (36) percent;
- (3) for expenditure on or connected with the development of sport and recreation, twenty-two (22) percent;
- (4) for expenditure on or connected with the arts, culture and the national historical, natural, cultural and architectural heritage, twenty-two (22) percent; and
- (5) for expenditure in respect of any other matter approved by the Minister for that purpose, five (5) percent.
