The Independent Communications Authority of South Africa hereby gives notice in accordance with the provisions of section 41(6) of the Independent Broadcasting Authority Act 153 of 1993, as amended, that an application has been received for a Temporary Community Sound Broadcasting and Signal Distribution Licence by Radio West Rand / Radio Westrand, broadcasting as West Rand Stereo/ Westrand Stereo. Material features of the application are as follows:
