**PROHIBITION ON THE MAKING OF FIRES IN THE OPEN AIR, THE DESTRUCTION BY BURNING OF GROUND COVER, INCLUDING SLASH, AND THE EXECUTION OF BLOCKBURNS; DISTRICT OF LETABA AND PIETERSBURG.**

I, Arnold Michael Muller in my capacity as the Director-General of the Department of Water Affairs and Forestry, hereby declare in terms of section 25(1), (2) and (3) of the Forest Act, 1984 (Act No. 122 of 1984), that in my opinion State Forests or Private Forests in the areas the boundaries of which are indicated in the Schedule A hereto are subject to an extraordinary fire hazards, I therefore-

1. direct that in the said area no person shall from **16 August 2002 up to and including 31 October 2002** make a fire in the open air, or if such a fire has been made, allow it to continue to burn or add fuel thereto, otherwise than-
  - a) fire made within a demarcated picnic or caravan park or holiday resort, but only at places within such an area which has been specifically prepared or maintained for that purpose: Provided that such fires are properly extinguished with water and / or sand;
  - b) fires for the preparation of food in the residential stand; and
  - c) fires made on residential and industrial stands in proclaimed townships
2. hereby direct that in the said area no person shall from **16 August 2002 up to and including 31 October 2002** destroy by burning any ground cover, including, or slash; and
3. hereby direct that in the said area no person shall from **16 August 2002 up to and including 31 October 2002** clear or maintain a fire belt by burning, or execute blockburns.

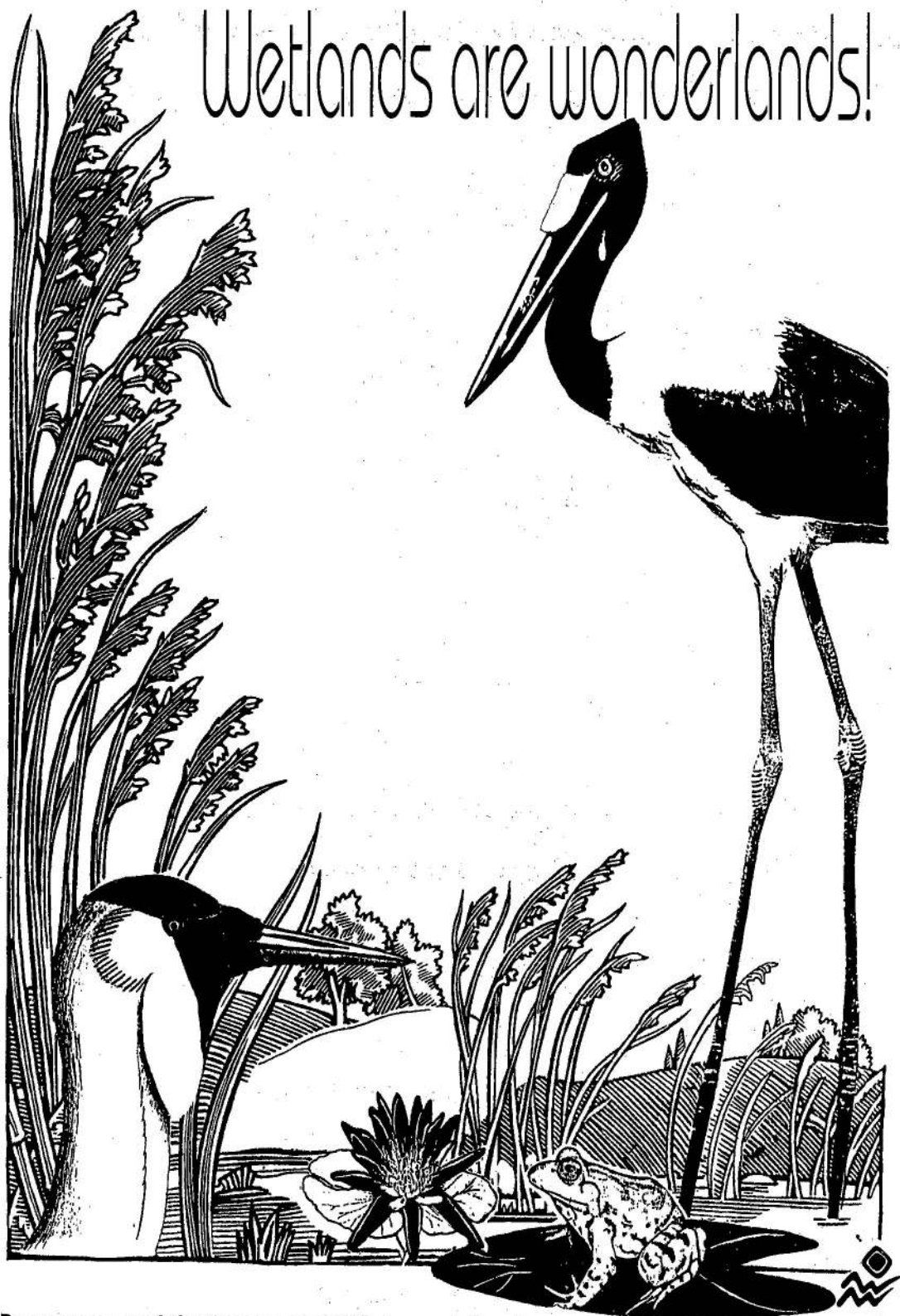
