Please note that no member of the government of the Republic of South Africa or of a provincial government or member of the Parliament of the Republic or of the legislature of any province or officer or employee of the government or any provincial government shall be appointed as a member of the Board of SA Tourism.

Nominations shall be persons who possess appropriate knowledge and/or experience in the areas of tourism development, marketing, human resource development or finance and business practice, or otherwise possess expertise in relation to any aspect of the activities of SA Tourism.
