SECTIONS 7, 7A AND 7B OF THE HERALDRY ACT, 1962 (ACT No. 18 OF 1962)

The undermentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for the registration of their heraldic representations and a name. Anyone wishing to object to the registration of these heraldic representations and a name on the grounds that such registrations will encroach upon rights to which he or she is legally entitled should do so within one month of the date of publication of this notice upon a form obtainable from the State Herald, Private Bag X236, Pretoria, 0001.

1. **Applicant: Mpumalanga College of Nursing (H4/3/1/3980).**

Flag: (College Flag) A rectangular flag, proportion 2:3, quarterly of blue and white, charged in the centre with a cross bottony, the foot splayed, counterchanged.

2. **Applicant: Mpumalanga College of Nursing (H4/3/1/3980).**

Flag: (Council Flag) A rectangular flag, proportion 2:3, checky of white and black, in two rows of four sections each, charged in the centre with a cross bottony, the foot splayed, counterchanged.

3. **Applicant: Mpumalanga College of Nursing (H4/3/1/3980).**

Flag: (Principal Flag) A rectangular flag, proportion 2:3, comprising three vertical bands of black, white and black, respectively 2/5, 3/5, 2/5 of the width of the flag, the white band charged with a blue double handled antique lamp, red enflamed, charged with a white cross potent, perched upon the handles, two swallows respectant proper.

4. **Applicant: The Noble Pier Felice degli Uberti, Count of Cavaglia (H4/3/4/643).**

Arms: Per pale, dexter, checky of five columns, Azure and Or, sinister Or, a demi bicephalous eagle Sable, crowned of a ducal crown Or, (for degli Uberti); at fess point, on an escutcheon Or, three fleurs-de-lis Azure, and on a chief of the last a horse passant Or, bridled and saddled Gules, (for Cicugnone, Counts of Cavaglia). The shield is ensigned with a comital crown of the Holy Roman Empire Or, embellished proper, heightened with eighteen pearls Argent.

Crest: On an Italian comital helm Argent, with nine grills and neckmedal or, the inner lining Gules, a comital crown embellished proper, heightened with eighteen pearls Argent, issuant therefrom a horse's head and neck Argent.

Mantling: Azure and Or.

Supporters: Statant upon the motto scroll, dexter a unicorn Argent, and sinister a lion Or, armed and langued Gules, crowned with an antique Italian noble crown also Or, each supporting two staffs in saltire behind the shield Argent, the upper ends each terminating in a fleur-de-lis Or, that to dexter bearing a banner checky of seven horizontal and vertical rows, Azure and Or, (for degli Uberti) and that to sinister, bearing a banner Or, there-upon three fleurs-de-lis Azure, and on a chief of the last a horse passant Or, bridled and saddled Gules (for Cicugnone, Counts of Cavaglia).

Motto: SINE VIRTUTE NULLA NOBILITAS.

War-Cry: OMNIA.

5. **Applicant: Mario Stefano Marco Teixeira De Albergaria, Baron of Greencastle, Lord of the Manors of Caher and Brierfield (H4/3/4/680).**

Arms: Per fess, Gules and Azure, a pale counterchanged, three mullets, two and one and as many crosses crosslet fitchy Or, one and two; on an escutcheon Argent, a cross flory Gules, voided of the field within an orlé of twelve escutcheons azure, each charged with five plates (for Albergaria).

Crests: (Dexter) A chapeau Vert, powdered with shamrocks Or, turned up Ermine, there-upon a wild cat, Ermine, passant guardant, resting his sinister forepaw on a rose Gules (for Sutherland); (Sinister) A chapeau Vert, powdered with shamrocks Or, turned up Ermine, there-upon a dragon passant, armed and langued Or, wings Goutty de Sang, collared Or, suspended therefrom a chain reflexed over the back Or, (for Albergaria).

Mantling: Vert, powdered with shamrocks Or, and Ermine.

Supporters: Dexter a dragon Or, wings Goutty de Sang, armed, langued and collared, therefrom a chain reflexed over the back Or; sinister a unicorn goutty de larmes, crined, armed, unguled and collared, therefrom a chain reflexed over the back Or.

Special compartment: Vert, scattered with thistles, shamrocks and roses proper.

Motto: EN AVANT SANS PEUR.

6. Applicant: Robert Owen Smith (H4/3/4/687).

Arms: Tierced in pairlé reversed, Vert, Azure and Sable, a fillet pall inverted Argent, between in chief two fleurs-de-lis of the last and in base a rose Argent, barbed Vert and seeded Or; at the fesspoint within an annulet an estoile of three points Or.

Crest: Issuant from a crest coronet consisting of a circlet heightened with four fleurs-de-lis Or, a dexter cubit arm Gules, holding a Celtic cross in bend sinister Argent.

Mantling: Azure and Or.

Motto: SEMPER ET UBIQUE FIDELIS.

7. Applicant: Robert Owen Smith (H4/3/4/687).

Badge: Charged upon a chaplet of shamrocks proper, two swords in saltire, points to base proper, hilts, grips and pommels Or, over all a torch of the last enflamed proper.

8. Applicant: Robert Owen Smith (H4/3/4/687).

Badge: Charged upon a chaplet of shamrocks proper, two swords in saltire, points to base proper, hilts, grips and pommels Or, enfiling an ancient crown consisting of a circlet heightened with four fleurs-de-lis, Or.

9. Applicant: Robert Owen Smith (H4/3/4/687).

Standard: In the hoist the arms of Robert Owen Smith and in the fly barry of four Or and Azure, divided into three compartments by two transverse bends Vert, cottised Or, charged with the motto SEMPER ET UBIQUE FIDELIS in letters Or, in the first and last compartment, charged upon a chaplet of shamrocks proper, two swords in saltire, points to base proper, hilts, grips and pommels Or, over all a torch of the last enflamed proper and in the second compartment, charged upon a chaplet of shamrocks proper, two swords in saltire, points to base proper, hilts, grips and pommels Or, enfiling an ancient crown consisting of a circlet heightened with four fleurs-de-lis, Or, the sleeve Azure and fringed comonly Azure and Or.

10. Applicant: Christi Sue Smith (H4/3/4/688).

Arms: Sable a lion dormant, between three estoiles, Or.

Crest: Issuant from a crest coronet consisting of a circlet heightened with four fleurs-de-lis Or, a bed of shamrocks Vert and six roses alternately Argent and Gules seeded Or, barbed Vert.

Mantling: Gules and Or.

Motto: FORTI ET FIDELI NIL DIFFICILE.

11. Applicant: Leo Brent Marchetti (Prince of Wohlauf) (H4/3/4/692).

Arms: Quarterly, per fess wavy, I, lozengy Azure and Argent; II, Argent a bull's head caboshed Gules, armed Or; III, Argent an eagle displayed Vert armed Sable; IV, Or, a goat clymant, fesswise of Sable and Argent. The shield ensigned with a helm Argent, garnished Or.

Robe: Gules and Ermine, fringed and tasselled Or, embellished purple. The robe ensigned of a coronet heightened of four pearled arches ensigned with an orb Argent and cross Or, within the coronet a cap Gules, the inner lining turned up over the circlet, ermine, the upper edge enarched indented.

Supporters: Statant upon a ribbon Purple, doubled Or, two unicorns proper.

Motto: FIDELITAS HONORIS ET SPES.

12. Applicant: Frederick Joseph Bainhauer III (H4/3/4/703).

Arms: Azure, two meat cleavers addorsed Argent, hilted Or, charged with two lion's heads also addorsed Gules, armed of the second, langued of the first, and in base two crosses flory Or.

Crest: Issuant from a tower Argent, a demi-lion rampant Gules, armed Argent, langued and with claws Azure, holding a cross paty of the last.

Wreath and mantling: Azure and Argent.

Motto: BE NOT AFRAID.

13. Applicant: Frederick Joseph Bainhauer III (H4/3/4/703).

Standard: In the hoist the arms of Frederick Joseph Bainhauer III and in the fly per fess Argent and Azure, divided into three compartments by two transverse bends Or, charged with the motto BE NOT AFRAID in letters Sable, in the first and last compartments each, a cross flory Or, and in the second compartment, the crest namely issuant from a tower Argent, a demi-lion rampant Gules, armed Argent, langued and with claws Azure, holding a cross paty of the last, the sleeve Azure and fringed comonly Azure and Or.

14. Applicant: Silvana Ghezze, Seigneur of Aurixis (H4/3/4/710).

Arms: Gules, a bend, between in chief, three stars, two and one, and in base as many, one and two, Or.

1. The Convention on the Privileges and Immunities of the United Nations (hereinafter referred to as "the Convention") shall be applicable in respect of the Summit. In particular, the representatives of States referred to in Article II, paragraph 1 (a) above, shall enjoy the privileges and immunities provided under Article IV of the Convention, the officials of the United Nations, performing functions in connection with the Summit referred to in Article II, paragraphs 1 (h) and 2 above, shall enjoy the privileges and immunities provided under Articles V and VII of the Convention, and any experts on mission for the United Nations in connection with the Summit referred to in Article II, paragraph 1 (g), shall enjoy the privileges and immunities provided under Article VI and VII of the Convention.
2. The participants referred to in Article II, paragraph 1 (b), (c) and (i) above, shall enjoy immunity from legal process in respect of words spoken or written and any act performed by them in connection with their participation in the Summit. The observers referred to in Article II, paragraph 1 (e) and (f) above, shall be accorded the appropriate facilities necessary for the independent exercise of their activities in connection with the Summit.
3. In carrying out their official functions for the United Nations, the personnel provided by the Government under Article VIII above, shall enjoy immunity from legal process in respect of words spoken or written and any act performed by them in their official capacity in connection with the Summit.

4. The representatives of the specialized or related agencies, referred to in Article II, paragraph 1 (d) above, shall enjoy the privileges and immunities of the Convention on the Privileges and Immunities of the Specialized Agencies or the Agreement on Privileges and Immunities of the International Atomic Energy Agency, as appropriate.
5. Without prejudice to the preceding paragraphs of the present Article, all persons performing functions in connection with the Summit, and all those invited or accredited to the Summit, shall enjoy, as applicable the privileges, immunities and/or facilities necessary for the independent exercise of their functions in connection with the Summit. Representatives of the press or of other information media shall be accorded the appropriate facilities necessary for the independent exercise of their activities in connection with the Summit.
6. All persons referred to in Article II, shall have the right of entry into and exit from South Africa, and no impediment shall be imposed on their transit to and from the Summit area. Visas and entry permits, where required, shall be granted to all those invited to the Summit free of charge, as speedily as possible and not later than two weeks before the date of the opening of the Summit. If the application for the visa is not made at least two-and-a-half weeks before the opening of the Summit, the visa shall be granted no later than three days from the receipt of the application. Arrangements shall also be made to ensure that visas for the duration of the Summit between 26 August to 4 September 2002 are delivered at the airport of arrival to those who were unable to obtain them prior to their arrival.
7. Distinguished guests officially invited to the Summit by the Government shall be given access to the Summit area by the United Nations.
8. For the purpose of the application of the Convention on the Privileges and Immunities of the United Nations, the Summit premises shall be deemed to constitute premises of the United Nations and access thereto shall be under the control and authority of the United Nations. The premises shall be inviolable for the duration of the Summit, including the preparatory stage and winding up.
9. All persons referred to in Article II above shall have the right to take out of South Africa at the time of their departure, without any restriction, any unexpended portions of the funds they brought into South Africa in connection with the Summit and to reconvert any such funds at the prevailing market rate.

An application has been filed with the Competition Commission by South African Airways (Pty) Limited (SAA) and Air Senegal Limited (Air Senegal) for an exemption from certain of the provisions of Chapter 2 of the Competition Act, 1998 (the Act) in respect of a code sharing agreement and a commercial agreement on the South Africa/Senegal/United States route.

The most important features of the agreement between the parties is that it provides for—

- ☐ the parties to co-ordinate their activities in respect of the route between South Africa, Senegal and the United States;
- ☐ SAA to sell to Air Senegal a number of seats on SAA's aircraft at a discount for Air Senegal to on-sell to customers at whatever price the latter may decide on.

The agreement would, on the face of it, contravene section 4 (1) (b) (ii) of the Act. The Act provides, in section 10 (3) (b), for four grounds on which an exemption application may be granted. A further ground in relating to the exercise of rights acquired in terms of the intellectual property laws of this country is also provided for in section 10 (4). The parties aver that two of these grounds are relevant, namely—

- ☐ the maintenance and promotion of exports [section 10 (3) (b) (i)]; and
- ☐ a change in productive capacity necessary to stop decline in an industry [section 10 (3) (b) (iii)].

The period for which an exemption has been applied for is two (2) years.

There is no agreement currently in place.

In terms of section 10 (6) of the Act, notice is hereby given of the application for exemption. Interested parties are afforded 30 days (thirty days) from the date of this Notice to make written applications as to why the exemption should not be granted.

"Subject to the provisions of section 20(2)(a)(i) and (ii) of the Act and subrules (2) and (3), the council shall register an applicant in the category of professional if the council is satisfied that the applicant -"; and
 - (b) by the addition after subrule (2) of the following subrule:

"(3) Notwithstanding the provisions of subrules (1) and (2), the council may, in its discretion, register a person currently registered as a professional associated valuer without a restriction or restrictions as a professional valuer if he or she applies for such a registration on or before 30 March 2003."

Substitution of rule 14 of Rules

3. Rule 14 of the Rules is hereby substituted by the following rule:

"Application of Assessment Outcome

 14. As a general norm, the minimum outcome reached in the assessment referred to in rule 13, shall -
 - (a) in the case of registration as a professional valuer, be a credit or weight of 190 and 10 types of properties valued for five purposes of property valuation;
 - (b) in the case of registration as a professional associated valuer without restrictions, be a credit or weight of 130 and eight types of properties valued for five purposes of property valuation; and
 - (c) in the case of registration as a professional associated valuer with restrictions, be a credit or weight of 80 and one type of property valued for one purpose of property valuation."

Amendment of rule 12 of Rules

4. Rule 12 of the Rules is hereby amended by the substitution in paragraph (a) for item (1) of the following item:

"(i) purchase, sale and capital gains tax;"
