## MANUAL OF THE PARLIAMENTARY SERVICE

### A. STRUCTURE AND FUNCTIONS OF THE PARLIAMENTARY SERVICE

#### I OFFICE OF SECRETARY TO PARLIAMENT

**Manager: Secretary to Parliament**

**Function:**

To ensure sufficient resources to provide legislative and institutional support services to Parliament in accordance with the guidelines and directives determined by the policy-making authority.

The Secretary is the chief executive officer of the Parliamentary Service, and reports to the National Assembly, the National Council of Provinces and the Joint Houses as represented by the Presiding Officers.

**Assistant Manager: Deputy Secretary to Parliament**

**Functions:** To monitor and ensure the implementation of operational policy decisions relating to tasks that various subcomponents of the Parliamentary Service must perform. The Deputy Secretary also oversees administrative compliance with governing policies and other implementation procedures.

#### SUBCOMPONENTS OF OFFICE OF SECRETARY TO PARLIAMENT

**Manager: Operations**

**Function:**

To provide functional and administrative support service to the Secretary's Office.

**Manager: Strategic and Business Planning**

**Function:**

To co-ordinate implementation of strategic and business planning and strategic projects and to advise on design/updating of policy directives and implementation.

#### 1. External Communications Sections

**Manager: External Communications Sections**

**Function:**

To coordinate external communications and relations of Parliament

##### 1.1. International Relations Office

**Manager: International Relations**

**Function:**

**Manager: Public Relations**

**Function:**

To advise the Presiding Officers on, and assist them with, the effective and efficient performance of their treasury functions under the legislation and directives governing the administration of the finances of Parliament, and to co-ordinate the internal audit function.

Function:

To assist the Secretary in the discharge of his or her accounting and financial reporting responsibilities by ensuring compliance with financial norms and standards determined for the Parliamentary Service and with generally recognised accounting practice.

Function:

To do financial planning and exercise financial control.

### **B. RECORDS OF PARLIAMENT**

#### **1. Papers tabled in Parliament**

Papers tabled in Parliament refer to annual reports and other reports that the State departments, constitutional bodies and public entities are submitting to Parliament as means of accounting to Parliament. State departments, constitutional bodies and public entities are required by the Constitution and their enabling legislation to account to Parliament on the performance of their functions.

The kinds of records that fall under papers tabled in Parliament are:

- Annual Reports from State departments, constitutional bodies and public entities;
- Reports of the Auditor-General; and
- International Agreements entered into between South Africa and other countries.

#### **2. Bills before Parliament**

Bills before Parliament are legislation proposals introduced in Parliament mostly by State departments that Parliament is still deliberating on to pass into Acts.

The kinds of records that fall under Bills before Parliament are:

- Bills introduced by State departments; and
- Bills introduced by members of Parliament.
- Bills introduced by committees of Parliament.

#### **3. Papers on the proceedings of the Houses of Parliament**

Parliament is made up of two Houses, which are the National Assembly and the National Council of Provinces. When Parliament is in session there are papers produced for the business of the Houses and those that emanate from their plenaries.

The kinds of records that fall under papers on the proceedings of the Houses of Parliament are:

- Order Papers (agenda document);
- Minutes of Proceedings of the House;
- Announcements, Tablings and Committee Reports;
- Question Paper (Questions to Ministers and the President);
- Internal Question Paper (register of questions);
- Hansard Book (record of debates); and
- Questions and Replies Book.

#### **4. Submissions from the public on Bills before Parliament**

When a Bill is introduced in Parliament it is immediately referred to a committee for consideration. The committee may, depending on the subject matter of the Bill, request the public to submit their opinions on the subject of the Bill. The committee will consider the submissions of the public in their deliberations and may invite some of the people who submitted their opinions to come and address them. These are termed submissions from the public on Bills before Parliament.

## **5. Publications on promoting public understanding of and participation in Parliament**

These publications are aimed at promoting understanding of the workings of Parliament and to promote public participation in Parliament.

The kinds of publications that fall under this category are:

- A Day in Parliament (Educational comic book explaining parliamentary processes);
- Spotlight on Parliament ( a series of ten resource pullouts for informing learners about Parliament);
- Parliament — Making Democracy Work (Folder with brochures explaining Parliament and how our democracy works);
- Insession (magazine aimed at informing and educating to achieve public participation in Parliament); and
- Participating in Parliament (facilitator's guide on how to run workshops on Parliament).
- Your guide to the Parliament of South Africa.

## **C. SERVICES AVAILABLE TO MEMBERS OF THE PUBLIC**

### **1. Guided tour of Parliament**

A guided tour of Parliament gives explanation on how Parliament works and includes historical background of the institution. The tour lasts for an hour and is free of charge. Tours are conducted from Monday to Friday between 09h00 and 12h00. Tours should be booked two weeks in advance.

### **4. Invitations to the public to comment/submit opinions on Bills before Parliament**

The invitations for members of the public to submit opinions on legislation before Parliament are advertised in national newspapers. The contact details of the person to whom submissions must be sent will be provided when invitations are advertised.

### **5. Briefing on the functioning of parliamentary committees**

The briefing explains how the parliamentary committees work and how the public can participate in them.

### **6. Form and manner of requests for accessing records**

Requests for access to records that are automatically available to the public can be made telephonically or by a facsimile, e-mail or post. There is no form to be filled as long as full particulars of the record to which access is requested are provided.

However, a requisition form as provided should accompany requests for records that are not listed as automatically available to the public. The request form can be mailed, faxed or e-mailed to Parliament.

### **7. Assistance to requesters**

The Deputy Information Officer of Parliament is charged with assisting requesters to comply with the Act when requesting access to records of Parliament. When a requester does not know which institution has possession or control of the record that he/she requests, the Deputy Information Officer will transfer the request to the institution that has the record or request it from that institution on behalf of the requester.
