ACT

To repeal the KwaZulu Cane Growers' Association Act, 1981; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Definition

- 1.** In this Act, unless inconsistent with the context—
“KwaZulu Cane Growers’ Association Act” means the KwaZulu Cane Growers’ 5
Association Act, 1981 (Act No. 12 of 1981).

Repeal of law

- 2.** The KwaZulu Cane Growers’ Association Act is hereby repealed.

Transfer of assets

- 3.** (1) The assets of the association acquired as a result of levies imposed under section 10
3(1) of the KwaZulu Cane Growers’ Association Act, including the balance of levies as
at the commencement of this Act, must be transferred to a trust to be established in terms
of the Trust Property Control Act, 1988 (Act No. 57 of 1988).

(2) The Minister must appoint suitable persons as trustees to administer the trust.

(3) The assets transferred to the trust contemplated in subsection (1) must be used for 15
the development of small cane growers in KwaZulu-Natal who paid levies in terms of
the KwaZulu Cane Growers’ Association Act.

Short title and commencement

- 4.** This Act is called the KwaZulu Cane Growers’ Association Act Repeal Act, 2002,
and comes into operation on a date to be fixed by the President by proclamation in the 20
Gazette.

WET

Om die Wet op die KwaZulu Suikerrietkwekersvereniging, 1981, te herroep; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Woordomskrywing

1. In hierdie Wet, tensy uit die samehang anders blyk, beteken—
“Wet op die KwaZulu Suikerrietkwekersvereniging” die Wet op die KwaZulu 5
Suikerrietkwekersvereniging, 1981 (Wet No. 12 van 1981).

Herroeping van wet

2. Die Wet op die KwaZulu Suikerrietkwekersvereniging word hierby herroep.

Oordrag van bates

3. (1) Die bates van die vereniging verkry na aanleiding van heffings opgelê kragtens 10
artikel 3(1) van die Wet op die KwaZulu Suikerrietkwekersvereniging, met inbegrip van
die saldo van heffings ten tyde van die inwerkingtreding van hierdie Wet, moet aan 'n
trust oorgedra word wat opgerig staan te word ingevolge die Wet op die Beheer oor
Trustgoed, 1988 (Wet No. 57 van 1988).

(2) Die Minister moet gesikte persone as trustees aanstel om die trust te administreer. 15

(3) Die bates oorgedra aan die trust beoog in subartikel (1) moet gebruik word vir die
ontwikkeling van kleinskaalse suikerrietkwekers in KwaZulu-Natal wat heffings betaal
het ingevolge die Wet op die KwaZulu Suikerrietkwekersvereniging.

Kort titel en inwerkingtreding

4. Hierdie Wet heet die Wet op die Herroeping van die Wet op die KwaZulu 20
Suikerrietkwekersvereniging, 2002, en tree in werking op 'n datum wat die President by
proklamasie in die *Staatskoerant* bepaal.
