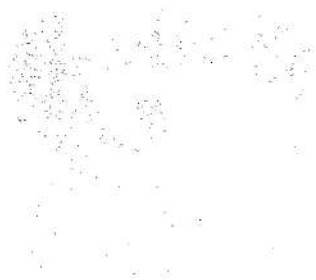

GENERAL NOTICE**NOTICE 1823 OF 2002****DEPARTMENT OF JUSTICE AND
CONSTITUTIONAL DEVELOPMENT****PUBLICATION OF EXPLANATORY SUMMARY
OF THE JUDICIAL MATTERS
AMENDMENT BILL, 2002**

The Minister for Justice and Constitutional Development intends introducing the Judicial Matters Amendment Bill, 2002 in the National Assembly shortly. The explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Bill aims to amend the Insolvency Act, 1936, so as to effect certain textual corrections; to amend the Magistrates' Courts Act, 1944, so as to further regulate the rescission of judgments; to amend the Stock Theft Act, 1959, so as to repeal certain obsolete provisions; to amend the General Law Further Amendment Act, 1962, so as to make further provision for access to children under custodianship; to amend the South African Law Commission Act, 1973, so as to effect a name change, to further regulate the appointment of members of the Commission, and to further regulate requirements in respect of the reports of the Commission; to amend the Companies Act, 1973, so as to further regulate the examination of directors and others during and after the winding up of a company; to amend the Criminal Procedure Act, 1977, so as to bring certain provisions in line with the Mental Health Care Act, 2002; to amend the Attorneys Act, 1979, so as to authorise the Attorneys Fidelity Fund Board of Control to enter into contracts for the provision of professional indemnity insurance cover and to further regulate payments to and from the Fidelity Fund; to amend the Correctional Services Act, 1998, so as to effect a technical correction; to amend the Promotion of Access to Information Act, 2000, so as to amend a definition; to make the Attorneys Act, 1979, applicable throughout the Republic; and to provide for matters connected therewith.

Die Minister vir Justisie en Staatskundige Ontwikkeling beoog om die Wetsontwerp op Geregte Like Aangeleenthede, 2002, eersdaags in die Nasionale Vergadering in te dien. Die verduidelikende opsomming van die Wetsontwerp word hierby ooreenkomstig Reël 241(c) van die Reëls van die Nasionale Vergadering gepubliseer.

Die Wetsontwerp het ten doel om die Insolvensiewet, 1936, te wysig ten einde sekere tekstuele regstellings aan te bring; die Wet op Landdroshowe, 1944, te wysig ten einde die vernietiging van vonnisse verder te reël; die Wet op Vee-diefstal, 1959, te wysig ten einde sekere verouderde bepalings te herroep; die Verdere Algemene Regswysigingswet, 1962, te wysig ten einde verdere voorsiening te maak vir toegang tot kinders wat onderhewig is aan ouerlike bewaring; die Wet op die Suid-Afrikaanse Regskommissie, 1973, te wysig ten einde 'n naamsverandering aan te bring, die aanstelling van lede van die Kommissie verder te reël, en die vereistes aangaande verslae van die Kommissie verder te reël; die Maatskappywet, 1973, te wysig ten einde die ondervraging van direkteure en ander persone tydens en na afloop van die likwidasië van 'n maatskappy verder te reël; die Strafproseswet, 1977, te wysig ten einde sekere bepalings in ooreenstemming met die Wet op Geestesgesondheidsorg, 2002, te bring; die Wet op Prokureurs, 1979, te wysig ten einde die Raad van Beheer oor die Getrouheidsfonds vir Prokureurs die bevoegdheid te verleen om kontrakte vir die verskaffing van versekeringsdekking vir professionele skadeloosstelling aan te gaan en om die betaling aan en vanuit die Getrouheidsfonds verder te reël; die Wet op Korrektiewe Dienste, 1998, te wysig ten einde 'n tegniese regstelling aan te bring; die Wet op Bevordering van Toegang tot Inligting, 2000, te wysig ten einde 'n woordomskriving te wysig; die Wet op Prokureurs, 1979, dwarsdeur die Republiek van toepassing te maak; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.
