NOTICE 3011 OF 2002**DEPARTMENT OF SAFETY AND SECURITY****PUBLICATION OF EXPLANATORY SUMMARY OF THE ANTI-TERRORISM BILL, 2002**

The Minister for Safety and Security intends to formally introduce the Anti-Terrorism Bill, 2002, in the National Assembly early in 2003. The explanatory summary of the Bill is hereby published in accordance with Rule 241(c) of the Rules of the National Assembly.

The Bill will repeal the Internal Security Act, 1982 (Act No. 74 of 1982).

The Bill is introduced in order to give effect within the Republic of South Africa to the relevant international instruments, principles and requirements relating to terrorism; to provide for certain offences related to terrorist acts in order to ensure the security of the Republic and the safety of the public against threats and acts of terrorism; to combat terrorist acts; to prohibit support and harbouring of proscribed organisations; and to provide for matters connected therewith.

KENNISGEWING 3011 VAN 2002**DEPARTEMENT VAN VEILIGHEID EN SEKURITEIT****PUBLIKASIE VAN DIE VERDUIDELIKENDE OPSOMMING VAN DIE WETSONTWERP OP ANTI-TERRORISME, 2002**

Die Minister vir Veiligheid en Sekuriteit beoog om die Wetsontwerp op Anti-Terrorisme, 2002, vroeg gedurende 2003 formeel in die Nasionale Vergadering in te dien. Die verduidelikende opsomming van die Wetsontwerp word hierby ooreenkomsdig Reël 241(c) van die Reëls van die Nasionale Vergadering gepubliseer.

Die Wetsontwerp sal die Wet op Binnelandse Veiligheid, 1982 (Wet No. 74 van 1982), herroep.

Die Wetsontwerp word ingedien ten einde binne die Republiek van Suid-Afrika voorsiening te maak vir die uitvoering van die tersaaklike internasionale instrumente, beginsels en vereistes met betrekking tot terrorisme; ten einde voorsiening te maak vir sekere misdrywe met betrekking tot terroristedade, ten einde die veiligheid van die Republiek en die veiligheid van die publiek teen dreigemente en dade van terrorisme te verseker; ten einde terroristedade te bekamp; ten einde ondersteuning en huisvesting van verbode organisasies te verbied; en om voorsiening te maak vir verbandhoudende aangeleenthede.
