NOTICE ON THE HOLDING OF ORAL HEARINGS ON THE INQUIRY INTO SPORTS BROADCASTING RIGHTS

The Independent Communications Authority of South Africa ("the Authority") published a Discussion Paper on the inquiry into Sports Broadcasting Rights, on 08 August 2002. The Discussion Paper was published in accordance with section 28 of the Independent Broadcasting Authority Act, 1993, as amended. The purpose of the Discussion Paper is to generate comment from all stakeholders on issues surrounding sports broadcasting rights as required by section 30(7) of the Broadcasting Act, 1999.

The Authority is going to hold oral hearings from 28 November to 04 December 2002 in Johannesburg (28 and 29 November 2002, and 03 and 04 December 2002) and Cape Town (02 December 2002).
